I wish to inform you that Mr. Roger J.E. Strobbe, the present Supervisor of the United Nations Memorial Cemetery in Korea, Pusan, is shortly proceeding on home leave and subsequently is being re-assigned to another United Nations Mission.

Effective 17 October 1964, I have designated Mr. Arthur L. Bourgois, presently Assistant Supervisor and General Services Officer, to be Supervisor.


I also wish to advise you that, upon the departure of Mr. Strobbe, it has been decided to reduce the number of United Nations international personnel assigned to the Cemetery from three to two. In this connection, arrangements are now in hand with the American Embassy, Seoul, from which Houses 421, 424 and 426, Hialeah Compound, are leased by UNMCK, on agreement, for the return of one house which will become surplus to requirements. The house in question is No.421 presently occupied by Mr. Robert V. Anderberg who will move to House No.426. We have suggested 31 October 1964 as the date of release of House No.421.



I understand from the Supervisor, United Nations Memorial Cemetery in Korea (UNMCK), Pusan, that he has received an enquiry concerning the telephone installation at the Cemetery.

In the above connection, I wish to refer to letter EUSA GL SI dated 8 January 1960 and letter dated 10 February 1960 addressed to the Assistant Custodian, UNMCK, by Brigadier General John A. Berry, General Staff, Deputy Chief of Staff for Administration, Hqs EUSA, paragraph 5 of which confirms that the "Army telephone line to be maintained from Cemetery to Army switchboard to insure easy contact with Seoul". Signal support is also approved in EUSA Circular 700-10 and has been further confirmed in the attachments to letter No. EUSA GL dated 7 April 1964 from Brigadier General R.P. Scott, Assistant Chief of Staff, G-4, EUSA. The actual telephone installation is governed by Contract for Sale of Telephone Service No. 1254 dated 1 August 1963 - Account No. 7-2254 B-2.

With regard to the necessity of this installation, I wish to advise that the Custodian and Assistant Custodian of the UN Memorial Cemetery are resident in Seoul and concurrently hold functions respectively as Principal Secretary and Chief Administrative Officer of the United Nations Commission for the Unification and Rehabilitation of Korea (UNCURK). It is therefore most necessary that an easy, speedy and reliable telephone contact is maintained between UNMCK, Pusan, and UNCURK, Seoul, to facilitate the many day-to-day activities relevant to the operation and maintenance of the Cemetery.

Further, it will be appreciated that operations at the Cemetery remain closely aligned to the activities in Korea of the United Nations Command and interments are governed by the following policy:

"A State having forces serving under the United Nations Command in Korea may, under conditions prescribed by the United Nations Custodian and subject to available space, arrange for burials in the United Nations Memorial Cemetery of any members of its forces who may die while serving under the United Nations Command in Korea."
