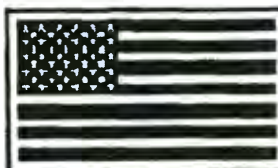

Dear Honorable Ban Ki-Moon:

This is regarding the horrific tragedy in the Philippines. My firm and I specialize in handling difficult and sometimes impossible food related catastrophes. Our history goes back many years when we provided the food for the Gdańsk, Gdynia blockade of Lech Walesa followers. The blockade prevented anything from going in or out of Gdańsk, Gdynia and we managed to supply most of their basic food needs for 3 years.

Afterwards, I developed a strategy to provide food for the Russian cities that could not get food after the breakup of the Soviet Union. The U.S. government's initial plan was to transport boat loads of grain which would be very impractical because it would take too long for the grain to arrive and then be processed into flour and baked into bread and there would only be bread and nothing else to eat. On the other hand my plan to the U.S. government proposed that they send out canned goods to the Russian people instead, which gave them a variety of foods that were ready to eat. This saved thousands of people from starving and saved the U.S. government millions of dollars.

We are very resourceful and imaginative and that is why we were selected to supply the UN troops in Haiti after the Earthquake. All the other companies that were approached wanted a considerable amount of time in order to study the situation and decide what had to be done and how to do it. In the meantime many people would die of starvation. We acted expeditiously and immediately and had significant amounts of foods in a steady basis within a few days. This lasted over six months until the outbreak of cholera and we were told that the project was complete. In the meantime we put UN troops on a good solid supply of all types of food stuffs consisting of meats, seafood, frozen foods, dairy, and even fresh produce. We were complimented on our organization of bringing in the food and for the variety and quality of the products that were supplied. The UN troops were able to save many lives and help many of those in need because they now had sustenance.
