1. SITUATION

a. GENERAL. THE SITUATION REMAINED GENERALLY CALM.

b. BORDERS.

(1) **SECTOR 1** - GATUNA AND KAGITUMBA BORDER POSTS WERE OPEN TO ALL TRAFFIC DURING THE PERIOD.

RUSUMO BORDER POST (RWANDA/TANZANIA) WAS OPEN TO NORMAL TRAFFIC.

(2) **SECTOR 1A** - RUTETE BORDER POST WAS OPEN TO ALL TRAFFIC.

(3) **SECTOR 3** - KANYARU HAUTE AND KANYARU BAS BORDER CROSSINGS WERE OPEN TO NORMAL FLOW OF TRAFFIC BETWEEN RWANDA AND BURUNDI

(4) **SECT 4** - ALL BORDERS WERE OPENED.

(5) **SECTOR 5** - NORMAL BORDER TRAFFIC BETWEEN UGANDA/RWANDA AT CYANIKA BORDER POST.

ZAIRE/RWANDA BORDER (GISENYI) IS CLOSED ON THE ZAIRIAN SIDE FOR IMMIGRATION OF RWANDAN NATIONALS. THE BORDER REMAINS CLOSED TO HUMANITARIAN AND UNAMIR TRAFFIC.

SECTOR 5(GISENYI) -

a. THE CASUALTY REPORTED ON DURING THE
HANDING-OVER CEREMONY AT GISENYI HAS BEEN FOUND
TO BE A LOCAL AND NOT A RPA SOLDIER AS EARLIER
STATED. HE IS SAID TO BE IN THE KIGALI HOSPITAL.

b. IT WAS REPORTED THAT ONE OF THE HELICOPTERS
HANDLED OVER BY THE ZAIRIAN GOVERNMENT WAS LOADED
UNTO A PRIME MOVER AND SENT TO KIGALI. IT WAS
STATED THAT THE SECOND HELICOPTER WILL BE
DESPATCHED TO GOMA TOMORROW 15 FEBRUARY 1996.

3. **OWN MILITARY ACTIVITIES**

A. **MILOB GP HQ**. CONTINUED COORDINATION AND MONITORING
OF MILOBS ACTIVITIES IN THE SECTORS.

B. **SECTOR 1 - KIBUNGO**.

(1) THE ACTING FORCE COMMANDER, CMO AND OTHER STAFF

UN RESTRICTED

OFFICERS PAID A WORKING VISIT TO THE SECTOR. THEY WERE TAKEN TO THE RUSUMO BORDER WHERE THEY WITNESSED THE RECEPTION OF RETURNEES FROM TANZANIA.

(2) ONE TEAM CONDUCTED PATROLS TO THE RUSUMO BORDER POST AND VISITED THE NYAKARAMBI (GR 7449) AND BIRENGA (GR 5958) TRANSIT CAMPS. THE SITUATION WAS SAID TO BE CALM.

(3) ANOTHER TEAM WENT TO KANZENZE (GR 8010) AND REPORTED THE SITUATION TO BE CALM. IT WAS STATED THAT 15 RETURNEES ENTERED THE COMMUNE ON THEIR OWN WITHOUT THE ASSISTANCE OF UNHCR BETWEEN 01 AND 14 FEBRUARY 96.

(3) A TEAM ALSO PATROLLED THE BYUMBA COMMUNE AND VISITED THE BYUMBA TRANSIT CAMP. IT WAS LEARNT THAT THE PRESIDENT OF RWANDA WILL BE VISITING THE CAMP TOMORROW, 15 FEBRUARY 96.

C. SECTOR 2 - GITARAMA.

(1) ONE TEAM VISITED RUNDA (GR 9882) AND TABA (GR 8883) COMMUNES. THE SITUATION WAS SAID TO BE CALM. THE TEAM ALSO VISITED RUYENZI TRANSIT CAMP.

(2) A SECOND TEAM PATROLLED MUKINGI COMMUNE. THEY ALSO VISITED NAYAGASUZI (GR 7361) AND MAHEMBE (GR 7160) SECTORS. THE SITUATION WAS SAID TO BE CALM.

E. SECTOR 3 - BUTARE.

(1) ONE TEAM PATROLLED NYAKIZU COMMUNE (GR 5694) OF THE BUTARE PRERFECTURE. IT WAS STATED THAT THE COMMUNE RECEIVED 71 RETURNEES IN JANUARY AND 98 SO FAR IN FEBRUARY.

F. SECTOR 4 - CYANGUGU. PATROL TEAMS VISITED NYAMASHEKE

G. SECTOR 5 - GISENYI.

(1) ONE TEAM VISITED THE COMMUNE OF NYAMYUMBA (GR 2106). THE SITUATION WAS FOUND TO BE CALM.

(2) ANOTHER TEAM PATROLLED THROUGH THE COMMUNES OF RWERERE (GR 2722) AND MUTURA (GR 3123). IT WAS NOTED THAT A TEAM OF UNHCR PERSONNEL WERE PUTTING UP STRUCTURES AT BORDER POINT 4; MUTOVU (GR 2829).

(3) A SECTION STRENGTH OF ZAIRIAN SOLDIERS WERE SEEN ON THE ZAIRIAN SIDE OF THE BORDER AT BP4; MUTOVU. THEY ARE SUPPOSED TO BE PART OF THE OUTER CORDON OF THE KIBUMBA REFUGEE CAMP. IT WAS ALSO NOTED THAT THE REFUGEES ARE RELUCTANT TO LEAVE THE CAMP.





1. SITUATION.

a. GENERAL. THE SITUATION REMAINS GENERALLY CALM.

b. BORDERS.

(1) **SECTOR 1.** KAGITUMBA, RUSUMO, RUTETE AND GATUNA BORDER POSTS WERE OPENED FOR TRAFFIC.

(2) **SECTOR 3.** KANYARU-HAUTE AND KANYARU-BAS BORDER CROSSINGS WERE OPENED TO NORMAL FLOW OF TRAFFIC BETWEEN RWANDA AND BURUNDI.

(3) **SECTOR 4.** ALL BORDERS WERE OPENED TODAY.

(4) **SECTOR 5.** ZAIRIAN/RWANDAN BORDER IS CLOSED ON THE ZAIRIAN SIDE FOR IMMIGRATION OF RWANDAN NATIONALS. THE BORDER REMAINS CLOSED TO HUMANITARIAN AND UNAMIR TRAFFIC. UGANDA/RWANDA BORDER (CYANIKA BORDER POST) IS OPENED FOR NORMAL TRAFFIC.

2. FACTIONAL ACTIVITIES.

a. POLITICAL. A CONFERENCE OF FOREIGN MINISTERS OF BURUNDI, UGANDA AND TANZANIA IS TAKING PLACE IN KIGALI TO DISCUSS THE DEVELOPMENT OF THE AKAGERA BASIN.

b. MILITARY.

(1) RPA.

(i) SECTOR 1 (KIBUNGO). CONTINUES CONDUCTING VEH AND FOOT PATROLS IN KIBUNGO AND KIGALI PREFECTURES, BOTH DAY AND NIGHT.

(ii) SECTOR 3 (BUTARE). PATROLLED AND MANNED ALL IMPORTANT PLACES AND CHECK POINTS.

(iii) SECTOR 4 (CYANGUGU). FIRING IN THE DIRECTION OF THE LAKE KIVU WAS MONITORED ON 11 JAN 96 AT 0230 HRS IN NYAMASHEKE. IT WAS GATHERED FROM GATARE COMMUNE (GR 1345) THAT RPA WAS ENGAGED IN FIRE EXCHANGE BY THE FRGF ELEMENTS NEAR THE FOREST. THREE FRGF MEN WERE REPORTED KILLED AND ONE ARRESTED.

(iv) AIR OPS CELL (KIA). THE RPA CONTINUES TO MAINTAIN STRICT SECURITY AT KIA.

(3) OTHERS: NTR.

3. OWN MILITARY ACTIVITIES.

a. MILOB GP HQ. CONTINUED COORDINATION AND MONITORING OF MILOBS ACTIVITIES IN THE SECTORS.

b. SECTOR 1 (KIBUNGO).

(1) ONE MILOBS TEAM VISITED NYAKARAMBI (GR 7449) AND BIRENGA (GR 5958) TRANSIT CAMPS AND THE RUSUMA BORDER POST (GR 8737). THE SITUATION WAS REPORTED TO BE CALM.

(2) ONE TEAM CONDUCTED AIR PATROL TO THE GATUNA BORDER POST (GR 0172) AND THE BYUMBA TRANSIT CAMP (GR 0825) AND REPORTED THE SITUATION AS CALM.

c. SECTOR 2 (GITARAMA).

(1) ONE TEAM VISITED RUTOBWE COMMUNE (GR 7781) AND REPORTED THE SITUATION AS CALM. EIGHT RETURNEES WHO HAD ARRIVED IN THE COMMUNE FROM ZAIRE ON 31 JAN 96 HAVE SETTLED DOWN IN THEIR RESPECTIVE SECTORS.

(2) THE SECOND TEAM VISITED MASANGO COMMUNE (GR 6254) AND REPORTED THE SITUATION TO BE CALM. COMMUNE JAIL FIGURES 253 INCLUDING 252 FOR GENOCIDE.

d. SECTOR 3 (BUTARE).

(1) A MILOBS TEAM PATROLLED MBAZI COMMUNE (GR 7117) OF BUTARE PREFECTURE. THE TEAM WAS INFORMED THAT SIX REFUGEES RETURNED TO THE COMMUNE IN JANUARY. ALL OF THEM HAVE BEEN SETTLED IN THEIR RESPECTIVE SECTORS.

(2) A TEAM PATROLLED NYABISINDU COMMUNE (GR 7138) OF BUTARE PREFECTURE. THE COMMUNE IS FACING HOUSING PROBLEMS FOR THE RETURNEES SINCE THEIR HOUSES HAVE

BEEN OCCUPIED BY OTHERS.

(3) A TEAM VISITED THE UNHCR OFFICE IN BUTARE TO COLLECT THE FIGURES OF RETURNEES.

e. **SECTOR 4 (CYANGUGU)**. PATROL TEAMS VISITED KIRAMBO (GR 0444) AND GATARE BORDER POINTS AND TRANSIT CAMPS. NO PROBLEMS IN RESPECT OF RETURNEES REPORTED.

f. **SECTOR 5 (GISENYI)**.

(1) ONE TEAM VISITED THE COMMUNES OF RWERERE (GR 2722) AND MUTURA (GR 3123). THE SITUATION WAS REPORTED AS CALM.

(2) ONE TEAM VISITED THE COMMUNES OF GASEKE (GR 4904) AND SATINSYI (GR 5800). THE SECURITY SITUATION IS REPORTED AS CALM. ON 07 FEB 96 AT RURAMA SECTOR (GR 5006) GASEKE COMMUNE A MAN WAS SHOT DEAD BY SOME UNKNOWN PERSONS. SIX PERSONS HAVE BEEN ARRESTED IN THIS CONNECTION. THE BURGOMASTER OF GASEKE REQUESTED FOR 16 FAMILIES PRESENTLY IN TRANSIT CAMP TO BE TRANSPORTED TO THE COMMUNE ON FRI 16 FEB 96. IN ADDITION HE REQUESTS FOR SOME SHEETING TO STORE FOOD DONATED BY THE LOCALS FOR THE RETURNEES. THIS REQUEST WILL BE PASSED ON TO UNHCR DURING TOMORROW BRIEF.

4. HUMANITARIAN ACTIVITIES. SECTOR 5 (GISENYI) REPORTED THAT TWO DUMPER TRUCKS AND A DOZER HAD ARRIVED FROM KIGALI TO ASSIST IN HUM TASKS REQUESTED BY THE SECTOR EARLIER.

5. CIVIL AFFAIRS. SECTOR 1 (KIBUNGO). INFORMATION ATTRIBUTABLE TO HUMAN RIGHTS (KIBUNGO) INDICATES THAT THE SECURITY AGENT OF GATI SECTOR (GR 4392) IN THE COMMUNE OF MUHAZI HAS REPORTED TO THAT COMMUNE HQ OF FINDING OF A DEAD BODY IN THE MUHAZI LAKE (GR 4696) ON 05 FEB 96. SOME ITEMS WERE ALSO STOLEN BY OTHER CIVILIANS IN OTHER PLACES. THE BOUGERMESTRE IS CARRYING OUT INVESTIGATION. THERE ARE 101 RETURNEES IN THE COMMUNE. IT WAS LATER FOUND AT ABOUT 0400 HRS OF 24

JAN 96 THAT TWO STUDENTS HAD BEEN SHOT IN THE DORMITORY AND THAT THE WIFE OF THE DIRECTOR HAD ALSO BEEN SHOT DEAD. A TOYOTA PICK UP DONATED BY THE MINISTRY OF EDUCATION WAS ALSO FOUND BURNT.

(2) TEAM PATROLLING KARAGO COMMUNE (4519) REPORTED THAT ON THE 11 JAN 96, A FARMER FROM RAMBURA SECTOR (4514) DETONATED AN ANTI-PERSONNEL MINE PLACED IN THE PATH USED BY SCHOOL CHILDREN. HE DIED LATER AND TWO SUSPECTS HAVE BEEN ARRESTED IN CONNECTION WITH THE INCIDENT.


