1. MPASE, DIRECTEUR DU CABINET OF ILEO TOLD SHERRY TODAY THAT ORDINANCE HAD BEEN ISSUED ATTRIBUTING TO ILEO EXERCISE IN POLICE POWERS JOINTLY WITH PROVINCIAL INTERIOR MINISTER. WE ASSUME HE CONFUSES SOME COORDINATING ROLE WITH ACTUAL CONTROL OF POLICE SINCE JOINT CENTRAL AND PROVINCIAL EXERCISE OF PURELY PROVINCIAL POWERS WOULD CONFLICT WITH BOTH FUNDAMENTAL AND THANT PLAN.
