



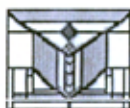

Dear Alex,

DPA has been in contact with UNDP, and recommends UNDP Administrator, Helen Clark, to represent the Secretary-General at this meeting. Excellency,

We have the honour to invite you to the International Donors' Conference for flood affected people in Bosnia and Herzegovina and Serbia which will be hosted by the European Commission and will take place in Brussels on the afternoon of 16 July – please see attached draft agenda. The European Commission together with France and Slovenia will co-organise and co-chair this event at a ministerial level.

Serbia and Bosnia and Herzegovina have recently suffered the worst flooding since records. The flood consequences, likely to be substantial, will have a long-term impact on the socio-economic growth of both countries and may significantly influence their ability to develop or consolidate their reforms agenda.

Serbia and Bosnia and Herzegovina do not have the capacity and resources to cope with the aftermath of the catastrophe on their own and have requested international financial and economic support for the recovery and the rehabilitation process.

The needs assessment reports, which are the result of a joint effort between the EU, the UN and the World Bank together with the national authorities, will be presented at the Donors' Conference and will provide a solid basis to identify financial needs and first policy recommendations. These reports will have been studied in detail at a senior official meeting which will take place in Paris on 8 July.

The European Commission, France and Slovenia place high priority on the economic recovery of both countries. In addition to mobilising international financial support, the Donors' Conference will also contribute to stepping up operational co-operation over flood and natural disasters in the region, and more generally to improve the resilience of economies.
