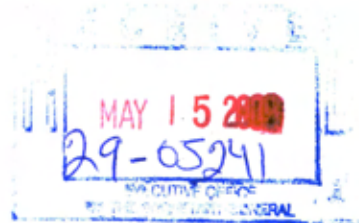

OBJET:

1. Please refer to Ms. Angela Kane's memorandum and attachment dated 28 April 2009 addressed to all heads of departments and offices on the above subject.

2. We would like to clarify the status of eight P-2 posts in DESA which are listed in the attachment as vacant or occupied by non NCE/non G to P, as follows:

- . 3 posts are temporarily vacant due to the temporary assignments of the regular NCE incumbents,

- . 2 posts for which requests for recruitment of NCE candidates were already submitted to OHRM,

- . 2 posts are filled by NCE staff members, and

- . 1 post is frozen by OHRM pending the results of the MRP process.

3. We will continue to work closely with Section C and the Staffing Service, OHRM, to fill all vacant posts with NCE candidates and continue to seek approval from those offices prior to recruiting temporary staff to fill P-2 posts on a temporary basis.
