SECURITY INSTRUCTION FOR THE EASTER
CELEBRATION WEEK 5-11 APRIL 96

GENERAL

1. This year's Easter Celebrations cover the period 3-10 April 96. The 5th of April has already been declared a holiday whereas normal routine will be observed for the period 3, 4 and 6-10 April 96.

2. The aim of this instruction is to lay down security details for the period.

OPS ROOM MANNING

3. Operations rooms will be manned 24 hrs during the period and available communications must be effective and manned throughout

RAPID REACTION FORCE

4. INDBATT will provide a Rapid Reaction Force (RRF) of 2 sections strength on standby in their Camp at 15 minutes notice to move from 3-9 April 96. MALAWICOY will provide 1 section RRF for the 10th of April 96.

5. The channel of employment of this force will be from the A/FC down through the COS and the COS INDBATT and MALAWICOY.

GUARD POINTS AND INSTALLATIONS

6. All designated guard points and installations will be fully guarded during the period.

RESTRICTIONS ON MOVEMENT

7. Earlier restrictions regarding the Security and Safety of UN personnel and equipment still hold good.

8. Additionally, curfew hours for the period for all UNAMIR personnel will start 2200 hrs and end at 0500 hrs on the mentioned dates.

9. Stand down for these security measures will be on 11 April 96 when the curfew hours will revert to starting at 2300 hrs.


VEHICLE SECURITY

10. Extra security measures must be taken to secure all vehicles when parked at the end of each day's work. Vehicles must be parked only in authorised secure places overnight. It is preferable to move with two vehicles after last light where possible and with escorts.


