Distinguished Representatives,

It was a pleasure to meet you on 15 September 2011 and to be informed about the campaign entitled "the flying chair – Palestine is deserving". Over the past months, the Secretary-General has been following closely the non-violent mobilization of so many from the civil society across the Middle East and North Africa to ask for greater freedom, dignity, justice and respect of human rights for all. This peaceful political awakening is truly inspiring. The historic changes taking place across the region are reasons for hope in a better future for all.

In this fast evolving context, ending the Israeli-Palestinian conflict and achieving the two-state solution is more urgent than ever. The establishment of an independent, sovereign, viable and democratic State of Palestine living side by side in peace with a secure State of Israel is long overdue. This is why the United Nations has spared no effort to promote a resumption of meaningful negotiations to resolve all permanent status issues and achieve a peace agreement that will bring a just and lasting settlement of the Israeli-Palestinian conflict and end the occupation that began in 1967, in accordance with Security Council resolutions 242 (1967), 338 (1973), 1397 (2002), 1515 (2003) and 1860 (2009), the road map, the Arab Peace Initiative and the principle of land for peace.

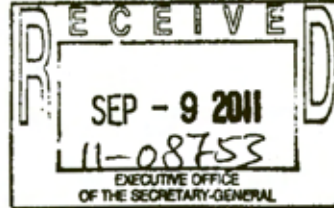
