ON THE OTHER HAND BUNCHE AND GARDINER SENT ME ON 25 NOVEMBER A POSITIVE MESSAGE APPROVING MY ACTION, A WELCOME ENCOURAGEMENT. 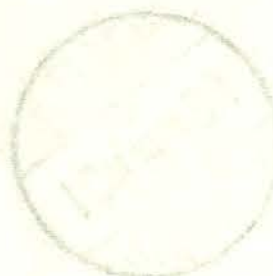
