Statement of expenditures from UNIC, Tokyo

1. Reference: the attached memo prepared by UNIC, Tokyo.

2. As instructed by the Chief Admin. Officer, all the expenditures in connexion with the session should as much as possible be billed to and paid first by the Center and subsequently be IOV'd to UNCURK, the following explanations should be helpful, especially in the absence of a UNIC Director and Mr. Sakakibara's first experience with the session held outside Tokyo.

- (a) VIP room charge at the Tokyo Airport on 4 Nov (¥8,800)
  When I arrived in Tokyo on 2 November, I asked Mr. Magistretti, the Acting Director of UNIC, and Mr. Sakakibara to help us in getting a VIP room at the airport in the afternoon of 4 November. I was told by UNIC on 3 November that the VIP room could me made available to us, but, according to the UN Section of the Japanese Foreign Ministry, we have to pay for it, the first time I have heard of this.
- (b) Toll charges paid by UNIC for taking me to Kawana (¥1,840)
  Upon my arrival at the Center, it had been arranged that Messrs.
  Verkade and Samanant be accommodated in a hotel which is about an hour drive from the Kawana Hotel. No accommodation had been made for Mr. Osman. In view of these developments and besides other pertinent problems, the Acting Director of UNIC advised that I should travel to Kawana in the Center's car together with his administrative officer, Mr. Sakakibara. Since the UNIC's driver was busy that evening, Mr. Sakakibara volunteered to drive me out so that he himself could make firm arrangements on the spot. At the same time, according to the Acting Director, the expenses would be much less than I would have paid in travelling on my own.
- (c) Train tickets for Ambassador Bas Backer
  The Ambassador made a last-minute decision to travel by train to Kawana.
  I presumed the Center arranged the travel for him. I met him at Itoh
  Station and took him in a hired car to the Kawana Hotel. On his return
  trip to Tokyo by train with Mr. Verkade, I bought two tickets for them.
- (d) Overtime work charges for Mr. Sakakibara (¥19,530)
  This is new to me. I hope the Chief Admin. Officer can settle it with UNIC.




