Excellency,

I have the honour to refer to the mandate of the United Nations Operation in Côte d'Ivoire (UNOCI) which expires on 31 May 2010. In operative paragraph 21 of its resolution 1911 (2010) of 28 January 2010, the Security Council expressed its intention to review in full by 31 May 2010, with a view to possible significant modifications, the mandate of UNOCI, the level of troops of the Mission and the benchmarks referred to in Annex I of my report of 7 January 2010 (S/2010/15), in light of the progress in the organization of the elections and the implementation of the other key steps of the peace process. The Council requested me, in operative paragraph 22 of the same resolution, to provide a report by the end of April 2010, including detailed recommendations and options for the future of UNOCI as well as revised benchmarks, based on the results of a technical assessment mission (TAM).

In this regard, an interdepartmental TAM travelled to Côte d'Ivoire from 12 to 23 April 2010 and the Secretariat, in close coordination with United Nations agencies, funds and programmes, is consolidating the findings of this mission, which will be included in my forthcoming report on UNOCI.

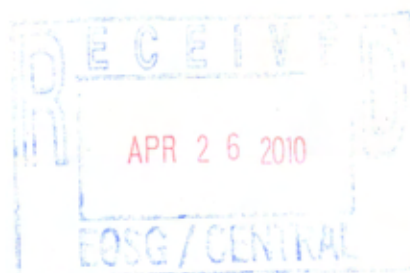
In order to provide the Council with a full picture of the rapidly evolving situation in Côte d'Ivoire, I propose that the Security Council authorize a technical rollover of the Mission's mandate for one month until 30 June 2010. This would allow the inclusion of the findings of the TAM and recommendations in my report, which would be issued by 31 May 2010.

I would be grateful if you could bring this letter to the attention of the members of the Security Council.

Please accept, Mr. President, the assurances of my highest consideration.

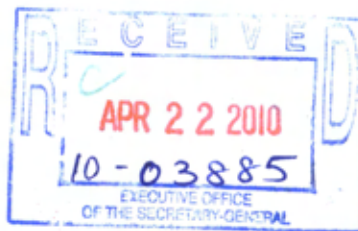

ONUCI: Letter to the President of the Security Council requesting a technical extension of the Mission's mandate

1. In resolution 1911 (2010), the Security Council expressed its intention to review in full by 31 May 2010, the mandate of ONUCI, in light of the elections and implementation of key steps in the peace process. The Council also requested the Secretary-General to provide a report by the end of April 2010. In this regard, an inter-departmental technical assessment mission (TAM) travelled to Côte d'Ivoire from 12 to 23 April, and the Secretariat is currently consolidating its findings and recommendations. In order to provide the Council with a full picture of the rapidly evolving situation in Côte d'Ivoire, we recommend that the Secretary-General proposes to the Council a technical extension of the Mission's mandate of one month, which would allow the inclusion of the TAM's findings and recommendations in the report.

2. We would be grateful for approval of this course of action. A draft letter from the Secretary-General to the President of the Security Council, recommending a one month technical roll-over of ONUCI's mandate is attached.
