2. I was present within 4 - 5 ft from the two of them when this was stated, but did not understand completely as my hearing is slightly impaired. This was repeated to me by Maj CONNELL, also present at the Swimming Pool, whereupon we both left immediately for ONUC HQ to see what the situation was.
3. When the foregoing statements were made, I do recall there was a member of the Press lying some 10 - 12 ft away from the Duty Officer talking to Col STETHAM. I consider that if this man's hearing was sharp, he may conceivably have seized at least part of the conversation which may account for news having spread about - according to Dr Linner and Mr Poujoulat.



Situation Lodja Area - 20 April

1. It is reported that Mr. OMENOMBE has been arrested and taken to Kindu.
2. Local Stan ANC claim he has gone to Kindu for conference with General Lundula.
3. Minister of Transport in Lodja said he had been arrested and beaten when captured.
4. Other reports say that he was arrested for brutality and cannibalism.
5. Message received from Stanleyville and addressed to ANC and ONU announcing the arrival of Minister of Justice and party.

Situation Kalonji State - 20 April

1. UN patrol to Tshiepele (16 miles SW of Dimbelenge) investigated the rumour of Kalonji troops in the area. 13 Kalonji soldiers were seen and the chief said they were there at his request.
2. The chiefs in area Kolombo Tshiepele intend to hold a meeting to decide whether to remain under Luluabourg administration or go over to Kalonji State.


Message to be passed by UN LO with ANO to General Mobutu.

Force Commander wishes that the following information received from General Lundula be passed to General Mobutu:-

"Kalonji Youth went as far north as Lodja on 5 July and some of them arrested yesterday by Stanleyville troops near Lodja.

Lundula has given orders to treat well the 20 prisoners ~~xxx~~ taken recently by his troops near Sentery. He points out that he cannot release them immediately, particularly in view of the confused military situation in Sakourou."

Behind these buildings and under our control is a large yard with access to the street at the far end of the office building. Around the yard are continuous two-storey buildings - shops - not under our control.

2. PX and Fuel Pumps

This is at the North East corner of the same cross roads as the office. The fuel pumps - a former "Shell" station - are at the corner. As part of the same group of buildings and adjacent to the fuel station in each of the two streets are two storey buildings under UN control. Each has five shops on the ground floor. In one street there is no gap between our building and the one next adjacent. In the other there is open access to a yard behind our building.

3. Old East Garage

"Stan, 6 Jun 61, No. 01123/CAB/VPM. Mister the Sec Gen of the UN New York. Sir I have the honour to manifest to you once more the government's good will to activate and facilitate the reunion of parliament in order to recover the national harmony.

If the Government proposed Kamina as the provisional seat of parliament it was for various reasons mainly the total security that this local offers in view of the presence of UN troops and of the presence of Congolese Army troops no matter from which area. This attitude shows we still keep confidence in the UN.

In the event that this proposal raises objections, the Government is prepared to reconcile and leave to the UN a free choice of location that would answer to the exigencies of the Government detailed in its letters of the 14 and 16 May 61. Amongst other points were the guarantee of the security of the parliamentarians, the evacuation of the Forces of the Congolese Army for a radius of 100 kms from the neutral zone the reunion of parliament under the complete protection of the UN Forces and the complete elimination of outside influence.

Within the framework of assistance we have never ceased to support the UN to facilitate its task, the Government accepts moreover the principle of negotiating under the auspice of the UN with the opposition in parliament if it exists, with due process and a practical system and technique. To this end a quick meeting between the parliamentary delegates of the two parties would be desirable always under the protection of the UN.

There being the firm will of all to end the crisis by the consultation of parliament to conform to the laws of the land and to the Security Council Resolutions of 21 Feb 61, I am convinced that the present letter will be approved of by all men of good will.

Please accept Mister the Secretary General the assurances of my highest consideration.

Activities of Foreigners in STANLEYVILLE

1. The following is submitted to you for consideration. The same is based on a report from Mr. LIAROMMATIS of HQ ONUC SOUTH KATANGA.

2. One Greek citizen of Yugoslavian origin, who is an inhabitant of STANLEYVILLE, is believed to be the real editor of the newspaper NHURU-INDEPENDENCE of LUMUMBA in STANLEYVILLE. Although his name does not appear on this newspaper, he is the brain behind it. His name is KOSTI KOSTIS and he is particular to hide his Yugoslavian origin. He was in EGYPT from November 60 to February 61 as a representative of GIZENGA's government. About a month back he was in ATHENS together with another man about whom we have no information. He is likely to be acting as a liaison between GIZENGA's government, EGYPT and YUGOSLAVIA. KOSTIS is believed to be still in ATHENS.

3. We have information to believe that arms and ammunition have been imported into STANLEYVILLE from various sources, among them those of Yugoslavian origin. Still more of such arms are expected to arrive there. It is very likely that this man KOSTIS is involved in this arms traffic to STANLEYVILLE authorities.

4. It may be also of interest to know, whether it is connected with the activities of the above individual or not, that about two months back Madame GRENFELL sent a letter from STANLEYVILLE to her husband in LEOPOLDVILLE and asked him whether she had his consent to send four of their children to be evacuated in YUGOSLAVIA. Mr. Georges GRENFELL is a Deputy of the CONGO Parliament and he is now living in the camp for political refugees in LEOPOLDVILLE under UN protection. A large number of children were taken recently by air to YUGOSLAVIA ostensibly for education.

Reference CIV. 47, have written a message to Lundulla stressing the points you have raised. Teshome and I further visited him this afternoon and I personally pressed Lundulla for a decision to go. I was struggling very hard but Lundulla refused flatly indicating that the Snakuru river is all for the reconciliation, that no action is necessary and if anything should be done the Adoula Government should send representatives to the area. Lundulla explained that the reason for the refusal to allow your plane to land at Lubefu was that the ONUC representatives were accompanied by Colonel Ndjoko, Nigerian Colonel Ewland, a Belgian adviser to the Provincial President in Luluabourg. None of these three persons are, as you know, very popular here, and especially Lundulla reacted against the presence of the Belgian. I asked Lundulla if he should react otherwise if I could give him some acceptable names, but he insisted that this matter was the duty of the Central Government. Lundulla's remarks were confirmed by ONIA ALBERT, Minister of Agriculture at Lulus, who was in Lundulla's office. Am sorry that I have had no success in spite of strenuous efforts, but I could not quite get away from the feeling that Lundulla's attitude was changed somewhat lately. He seems to be more critical to UN now and especially he complains at the Nigerians. Lundulla might be under pressure from some elements opposing the reconciliation.
