LC 04017 SITUATION REPORT. QUARREL ENSUED BETWEEN ONE GENDARMER
SOLDIER ON GUARD AT ECOOLE CENTRAL, LULUABOURG TOWNSHIP
AND A CONGOLESE CIVILIAN. CIVILIAN CONGOLESE WAS REPORTED TO
HAVE STABBED THE GENDARM. ANOTHER GENDARM ON GUARD SHOT ~~XXXX~~ THE
CIVILIAN DEAD AS HE WAS TRYING TO ESCAPE. ONE PASSERBY ALSO
INJURED AS A RESULT OF THE SHOT. MANY CIVILIAN POPULATION
SCARED BY THE INCIDENT. HAVE PLACED ARMED GUARDS AT ONUC HQ
AND WORKSHOP. CURFEW IMPOSED FROM 1700Z. GUARDS WILL BE

UNCLAS AOL 302 OSORTIO TAFALL FROM SCHELLER.

THIS MORNING ONE CIVILIAN KILLED AN ANC GUARD IN FRONT OF
LYCEUM KELEKELE IN LULUABOURG. WHILE ESCAPING HE WAS SHOT TO
DEATH BY THE OTHER ANC GUARD. A PANIC STARTED IN THE LYCEUM
AND ADJOINING QUARTERS POPULATION FEARING REPRISALS FROM THE
ARMY. I WENT TO SCENE WITH COL MASSIALA AND ~~XXX~~ SOME GOVERN-
MENT OFFICIALS. COL MASSIALA IS GOING TO QUIETEN THE SOLIDERS
AND THIS AFTERNOON SITUATION IN TOWN SEEMS NORMAL ~~XX~~ EXCEPTING
SHOPS CLOSED. THIS INCIDENT WHICH COULD EASILY DEGENERATE IN
LARGE ~~XXXXXXXXXX~~ KILLING AND LOOTING SEEMS SETTLED IF SOLDIERS
ARE KEPT IN THE QUARTERS TONIGHT.

ACCORDING TO UNCONTROLLED INFORMATION, FROM UNOFFICIAL ^{*sources,*} SOLDIERS COMING FROM SOUTH KASAI PROVINCE HAVE ATTACKED ~~THE~~ 29TH OF MAY AND KILLED ABOUT 40 POLICEMEN IN MWENE DITU CONTESTED AREA. IN ADDITION ASSISTANT SPECIAL ADMINISTRATOR AND ABOUT 7 ^{*NOTABLES*} ~~NOTABILITIES~~ OF KANIOKA TRIBE HAVE BEEN ARRESTED BY ORDER OF BAKWANGA PARQUET AND SENT TO THIS TOWN. STATE ATTORNEY IN LULUABOURG WHO BROUGHT ME THIS INFORMATION IS ORDERING THE TRANSFER OF THE ALLEGED PRISONERS TO LULUABOURG.
