a. **GENERAL.** THE SITUATION REMAINS GENERALLY CALM.

- (1) **SECTOR 1.** KAGITUMBA, RUSUMO, RUTETE AND GATUNA BORDER POSTS WERE OPENED FOR TRAFFIC.
- (2) **SECTOR 3.** KANYARU-HAUTE AND KANYARU-BAS BORDER CROSSINGS WERE OPENED TO NORMAL FLOW OF TRAFFIC BETWEEN RWANDA AND BURUNDI.
- (3) **SECTOR 4.** ALL BORDERS WERE OPENED TODAY.

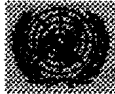

- (3) LOCALS CONFIRMED THE PRESENCE OF INFILTRATORS IN THE CELLULES OF KINOGO (2829) AND VUNA (2828) BUT DECLINED TO GIVE DETAILS.
- (4) MILOBS BEGIN TO THIN OUT FROM SECTOR WEF DATE.

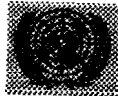

(2) A PATROL WAS CONDUCTED IN CONJUNCTION WITH MEDICAL TEAM FROM INDBATT AND AN ARMED RPA ESCORT TO THE COMMUNE OF MUGESERA (GR 4764) TO INVESTIGATE THE REPORTED HIGH INCIDENCE OF MALARIA IN THE NYANGE SECTOR (GR 3866). THE MEDICS WERE NOT ALLOWED TO TAKE BLOOD SAMPLES FOR TESTING DESPITE PERSUASION BY THE MILOB TEAM. ALL WAS SAID TO BE CALM.

(4) A CITY PATROL WAS CONDUCTED THROUGH KIGALI CITY BY ANOTHER TEAM. THE SITUATION WAS SAID TO BE CALM.

(1) MILOBS TEAM ON HELI-PATROL VISITED NYAKABANDA (6597) AND NYABIKENKE (7292) COMMUNES (GR9267) AND REPORTED THE SITUATION AS CALM. CASES OF BANDITRY

IS NOW RAMPANT, AND IN NYABIKENKE COMMUNE IT WAS REPORTED THAT TWO BUSINESSMEN WERE ATTACKED AND ROBBED OF AN AMOUNT OF 400,000 FRW ON 24 FEB 96. THE BANDITS WERE SAID TO HAVE BEEN ARRESTED IN KIGALI ON 29 FEB 96. 80 RETURNEES WERE SAID TO HAVE ARRIVED IN THE COMMUNE DURING THE MONTH OF FEB96.

d. **SECTOR 3 (BUTARE):**

(1) MILOBS TEAM VISITED THE BUTARE AND GIKONGORO PREFECTURES AND REPORED THE SITUATION AS CALM.

e. **SECTOR 4 (CYANGUGU):** PATROL TEAMS VISITED KIBOGORA (GR 0444),BUGARAMA BORDER POINTS AND TRANSIT CAMPS. NO PROBLEM IN RESPECT OF REFUGEES REPORTED.

(1) ONE TEAM VISITED THE COMMUNE NYAMYUMBA (GR 2106) AND REPORTED THE SITUATION AS CALM. TEAM ALSO VISITED THE CARITAS CLINIC AT KIVUMU (GR 2303) WHERE THE INDBATT EME DET HAD INSTALLED A GENERATOR SET AND HELPED LAY OUT POWER CABLE ON THE REQUEST OF THE NGO.

(2) THE AMBASSADOR MET THE GOVERNOR OF NORTH KIVU REGION YESTERDAY AND THE LATTER CONFIRMED THAT THE HELI WAS PRESENTLY IN KINDU, APPROX 500 KM SOUTH-EAST OF GOMA. THE TARMAC AIRSTRIP IN KINDU IS BELIEVED TO TAKE BOEING 737 AND THUS SHOULD BE ABLE TO RECEIVE C-130 TYPE AIRCRAFTS.

(3) ACCORDING TO THE AMBASSADOR THE ZAIRIAN SIDE REFUSED TO BRING THE HELI TO GOMA DUE TO BOTH FINANCIAL AND LOGISTICAL PROBLEMS, AT THE SAME TIME THE ZAIRIAN

MINISTER OF DEFENCE AGREED WITH THE IDEA TO EMPLOY THE UNAMIR PLANE.

(4) IN CASE THE OPERATION BECOMES FEASIBLE, THE UNAMIR PLANE SHOULD LAND FIRST IN GOMA TO PICK UP LOCAL MECHANICS AND THEN FLY TO KINDU WHERE THEY WILL LOAD THE HELI.

(5) THE ZAIRIAN MINISTER OF DEFENCE WILL STAY IN GOMA FOR ANOTHER DAY OR TWO, SO IT WAS SUGGESTED THAT ALL REQUESTS SHOULD BE MADE THROUGH HIM AND NOT THROUGH THE ZAIRIAN FOREIGN MINISTRY BECAUSE THEY KNOW LITTLE ABOUT THE HANDING-OVER OF WEAPONS AND PRECIOUS TIME WILL BE LOST.

(6) LATER TODAY THE AMBASSADOR AND RPA BN CDR WERE ADVISED TO PROCESS THE REQUEST THROUGH THE RWANDAN GOVT TO UNAMIR.

1. SITUATION

a. GENERAL. THE SITUATION REMAINED GENERALLY CALM.

b. BORDERS.

(1) **SECTOR 1** - GATUNA AND KAGITUMBA BORDER POSTS WERE OPEN TO ALL TRAFFIC DURING THE PERIOD.

RUSUMO BORDER POST (RWANDA/TANZANIA) WAS OPEN TO NORMAL TRAFFIC.

(2) **SECTOR 1A** - RUTETE BORDER POST WAS OPEN TO ALL TRAFFIC.

(3) **SECTOR 3** - KANYARU HAUTE AND KANYARU BAS BORDER CROSSINGS WERE OPEN TO NORMAL FLOW OF TRAFFIC BETWEEN RWANDA AND BURUNDI

(4) **SECT 4** - ALL BORDERS WERE OPENED.

(5) **SECTOR 5** - NORMAL BORDER TRAFFIC BETWEEN UGANDA/RWANDA AT CYANIKA BORDER POST.  
ZAIRE/RWANDA BORDER (GISENYI) IS CLOSED ON THE ZAIRIAN SIDE FOR IMMIGRATION OF RWANDAN NATIONALS. THE BORDER REMAINS CLOSED TO HUMANITARIAN AND UNAMIR TRAFFIC.

2. FACTIONAL ACTIVITIES

A. **POLITICAL**. SECTOR 1 ( KIBUNGO) --- THE PRESIDENT OF RWANDA WAS REPORTED TO HAVE VISITED BYUMBA PREFECTURE AND ADDRESSED THE LOCALS TODAY.

B. **MILITARY**.

(1) **RPA**.

a. **SECTOR 1A (KIGALI)** - CONTINUED TO PERFORM RANDOM PATROLS AND ROADBLOCKS.

b. **SECTOR 3 (BUTARE)** - PATROLLED AND MANNED ALL IMPORTANT CHECK POINTS.

c. **SECTOR 4 ( CYANGUGU)**- RPA WAS OBSERVED TO HAVE INTENSIFIED FOOT PATROL AT MUTUMBARA (GR 9837) AND KAGARAMA (GR 9633). REASONS FOR ACTION MUST BE CONNECTED WITH SHOOTING REPORTED IN THE NYAMASHEKE COMMUNE ON 11 FEB 96.

d. **SECTOR 5 (GISENYI)**-- ACCORDING TO LT COL PATRICK OF RPA, 4 APCS HANDED OVER BY ZAIRIAN AUTHORITY CAN NOT BE RESTORED IN GISENYI AND NEED TO BE TRANSPORTED TO KIGALI. LOW LOADER IS REQUIRED AT THIS LOC. THE WHEREABOUT OF THE SECOND GAZELLES HELI IS YET TO BE CONFIRMED.

e. **AIR OPS CELL (KIA)** - THE RPA CONTINUE TO MAINTAIN STRICT SECURITY AT KIA.

(2) **FRGF**. SECTOR 4 (CYANGUGU)--- AT KERANGERA (GR9211) ON 8 FEB 96, A MAN WAS KILLED BY GROUP OF GUN MEN BELIEVED TO BE FRGF. THE ASSASSINS WENT TO THE MAN'S HOUSE TO ROB HIM AND GOT HIM KILLED IN THE PROCESS.

(3) **OTHER**. NTR.

3. OWN MILITARY ACTIVITIES

A. MILOB GP HQ. CONTINUED COORDINATION AND MONITORING OF MILOBS ACTIVITIES IN THE SECTORS.

B. SECTOR 1 - KIBUNGO.

(1) ONE TEAM CONDUCTED PATROLS TO THE RUSUMO BORDER POST AND VISITED THE NYAKARAMBI (GR 7449) AND BIRENGA (GR 5958) TRANSIT CAMPS. THE SITUATION WAS SAID TO BE CALM.

(3) ANOTHER TEAM WENT TO GASHORA COMMUNE (GR 5627) AND VISITED DIHIRO ( GR 5324) TRANSIT CAMP AND REPORTED THE SITUATION TO BE CALM.

(2) THE SECOND TEAM PATROLLED MWEDO COMMUNE (GR6254) AND REPORTED THE SITUATION TO BE CALM. THE TEAM VISITED KIGOMA SECTOR (GR 4658) AND GASHAU SECTOR ( GR 4563) AND SPOKE TO LOCALS WHO CONFIRMED THAT THE SITUATION WAS NORMAL. NO RETURNEES HAVE ARRIVED IN THE COMMUNE THIS YEAR.

E. SECTOR 3 - BUTARE.

(1) ONE TEAM PATROLLED MUGUSA (GR 8425) COMMUNE OF

UN RESTRICTED

THE BUTARE PRERFECTURE. THE COMMUNE RECEIVED 89 RETURNEES SINCE DEC 95 TO DATE. COMMUNE HAS NO MAJOR PROBLEM IN THEIR RESETTLEMENT EXCEPT FOR FOOD FOR RETURNEES.

(2) ONE TEAM PATROLLED MUYAGA COMMUNE (GR 9026) OF BUTARE PREFECTURE. THE COMMUNE HAS RECEIVED 402 RETURNEES IN JAN AND 727 IN FEB 1996 TO DATE. COMMUNE FACES PROBLEM OF FOOD FOR THEIR RETURNEES.

(3) ONE TEAM VISITED UNHCR OFFICE AT BUTARE TO COLLECT THE FIGURES OF RETURNEES.

F. **SECTOR 4 - CYANGUGU.** PATROL TEAMS VISITED NYAMASHEKE (GR 9841), BUTAMBARA (GR9837), BORDER POINTS AND TRANSIT CAMPS. NO PROBLEMS IN RESPECT OF REFUGEES REPORTED.

G. **SECTOR 5 - GISENYI.**

(1) SECTOR HQ - THE AFC VISITED TODAY AND WAS BRIEFED BY THE SECT COMD ABOUT THE SECURITY SIT AND CONTIGENCY PLAN FOR ANTICIPATED REPATRIATION FROM KIBUMBA CAMP.


