**Proposed Meeting of the Secretary-General with
Members of the Bhutto Commission of Inquiry**

1. As you are aware, the Secretary-General announced the commencement of activities of the Commission of Inquiry into the assassination of former Prime Minister of Pakistan Mohatarma Benazir Bhutto from 1 July. The Chair of the Commission, Ambassador Heraldo Muñoz, and Commissioners Mr. Marzuki Darusman and Mr. Peter Fitzgerald will convene in New York prior to their first mission to Pakistan scheduled for 15 July.

2. It would be desirable for the Commissioners to meet with the Secretary-General in advance of their visit to Pakistan, in order to update him on the Commission's plans. We propose for this purpose the dates of 10 July or 14 July. Your meeting with the Commissioners on either of those dates would be desirable as well.
