
Excellency,

I write to acknowledge, with thanks, your letter dated 14 July 2014, in which you requested a meeting between the Secretary-General and His Excellency Mr. Antoni Martí Petit, Head of Government of the Principality of Andorra, accompanied by His Excellency Mr. Gilbert Saboya Sunyé, Minister for Foreign Affairs of the Principality of Andorra, between 22 and 27 September 2014.
