On behalf of MSF, I would also like to thank you for your personal commitment to developing a global and comprehensive response to the Ebola outbreak in West Africa.

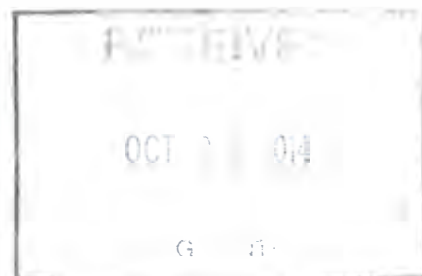
