INTRODUCTION

1. We would like to bring further clarification to the report reference A, which was the same subject as our reference B SITREP.

BACKGROUND


2. As indicated in our reference B SITREP, one MILOB team conducted an helipatrol to NYARUBUYE GR (SC2353), in the GISOVU commune, on 07 July 95.

3. Some time following the patrol, the Sector Comd had an interview with the CO 92ND RPA Bn who stated that he had been informed that a MILOB team, during subject patrol, had asked the local population not to give information to the RPA. The Sector Comd informed the RPA CO that this information was false and was not part of our mission. After many clarifications the RPA CO told the Sector Comd that he was satisfied with the explanation and that their relationship together was excellent and without problems.

CONCLUSION

4. It should be noted that at no time, during the conversation with the CO 92ND RPA Bn and the Sector Comd, was there any allusion or discussion of the subject as presented in the reference A report: the alleged encouragement of the MILOBS to the local population "to co-operate with INTERHAMWE".

5. Notwithstanding any of this, rest assured that at no time any MILOB in this Sector did such a thing during the helipatrol as is alleged in reference A report.
