

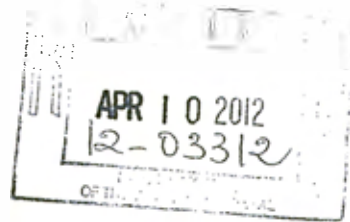

We would also like to point out that we have received approval for the bilateral meeting your Excellency requested with His Majesty King Abdullah Bin Abdulaziz Al-Saud.

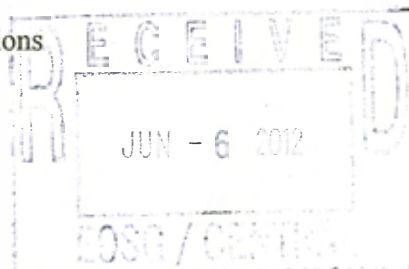

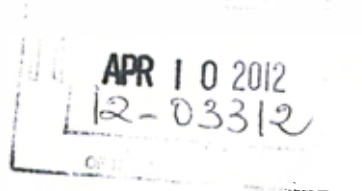
