Thank you again for taking the time to meet with me.

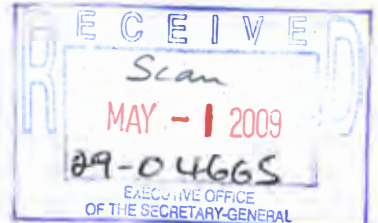
