SWISS CONSUL GENERAL HAS BEEN INFORMED THAT THE CONRAZ AFFAIR IS ESSENTIALLY A MATTER BETWEEN THE SWISS GOVERNMENT AND THE KATANGHE/CONGO AUTHORITIES. CONG IS PREPARED TO GIVE ALL NECESSARY ASSISTANCE BUT DID NOT WISH TO LET THE HANDLING OF CONRAZ BECOME A SOURCE OF FRICTION BETWEEN CONG AND THE KATANGHE LEADERS. THE CONSUL HAS DECIDED TO GO TO EVILLE FOR NEGOTIATIONS WITH THE KATANGHE AUTHORITIES, BUT PRIOR TO THIS THE CONSUL GENERAL WOULD CONSULT THE AMBASSADORS OF THE UNITED STATES AND UNITED KINGDOM AND THE BELGIAN CHARGE D'AFFAIRES. THE CONSUL GENERAL IS CABLEING TO BERNE FOR INSTRUCTIONS WHICH WILL BE TRANSMITTED TO COSIL JACCAUD WHO LEAVES LEOPOLVILLE 0530 AM NY TIME PLANE FOR EVILLE. THE PROTECTION OF CONRAZ SHOULD CONTINUE UNTIL FORMALLY HANDED OVER TO SWISS AUTHORITIES WITH THE FULL KNOWLEDGE OF THE CONSULAN CORPS IN EVILLE.

WOULD APPRECIATE YOUR REACTION AS TO WHETHER OR NOT IT WOULD BE FEASIBLE AND HELPFUL TO ADVISE TSHOMBE THAT ONUC INTERPRETS BROADLY THE ASSURANCE GIVEN BY ADOULA IN HIS LETTER OF FEBRUARY 28; THAT THE QUESTION OF A PARLIAMENTARY ARREST WARRANT POSED NO THREAT TO HIS SECURITY AT KITONA WHICH HAD BEEN GUARANTEED BY THE UNITED NATIONS; THAT IF IT HAD BEEN RAISED, ONUC WOULD HAVE OPPOSED ITS APPLICATION ON THE GROUNDS THAT WOULD NULLIFY THE SECURITY ASSURANCE WHICH ONUC HAD GIVEN TO TSHOMBE WITH THE AGREEMENT OF THE LEOPOLDVILLE GOVERNMENT; AND THAT IF NECESSITY SHOULD ARISE, WE WOULD, OF COURSE, TAKE THE SAME POSITION IN CONNEXION WITH TSHOMBE'S VISIT TO LEO. UNQUOTE.
