The United Nations Observer Mission Uganda/Rwanda presents its compliments to the Secretary of Defence, and wish to bring to your kind notice that UNAMIR has a Liaison Team now based in Goma(Zaire) for carrying out required Liaison with French Force. With the positioning of a UN Team at Goma, it has become difficult for UNAMIR to support logistically, arranging relief and maintaining command and Liaison with the team from Kigali.

2. In light of above it has become necessary for UNAMIR to maintain the command and liaison with the team in Goma by using UNOMIR helicopter located in Kabale. The helicopter will be used as and when required from Kabale to Goma through route - Kabale-Kisoro-Bumagama-Goma.

3. We will appreciate the kind clearance of the Ugandan government to fly UNOMIR helicopters to Goma/Zaire. Necessary clearance from Zairean Government being obtained by UNAMIR vide reference B.


4. The United Nations Observer Mission Uganda/Rwanda avails itself of this opportunity to renew its highest esteem and considerations at all times.

5. UNAMIR Liaison Team at Goma Only. Kindly arrange to ensure following:

- a. Clearance from Zairean Government.
- b. Landing and ground facilities at Goma airport/airfield.
- c. Refuelling facility at Goma airport/airfield.
- d. Intimate location of the Airfield/Airport to this HQ.
