MESSAGE TO INTERNATIONAL CONFERENCE
ON GREEN INDUSTRY IN ASIA
Manila, 9 September 2009

*Delivered by Ms. Jaqueline Badcock, Resident Coordinator
of the United Nations System in the Philippines*

I am pleased to greet all participants in the International Conference on Green Industry in Asia. I thank the Government of the Philippines for hosting this important event.

We are now less than 100 days away from the start of the vital United Nations Climate Change Conference in Copenhagen. There are only 15 negotiating days left until Copenhagen begins. Climate change carries no passport. No nation is immune from its effects, and no nation can respond effectively alone. Without global cooperation, we will not succeed.

But if we can come together in genuine partnership at Copenhagen, we can move decisively to build a low-emissions economy. We can power green growth. We can protect the world's forests, and those whose livelihoods depend on them. We can create new avenues to prosperity for the billions of people who have limited access to energy, water and other basics.

The threats posed by climate change are real. But so, too, are the possibilities for changing course. This year, we have an historic opportunity to combat climate change, promote sustainable development, fight poverty and protect the environment. The international community must rise to the challenge – first, at the Climate Summit I am convening in New York on 22 September, and then at Copenhagen in December.

Green industry is at the heart of our hopes for the future. The greening of industry will stimulate clean energy investments, encourage innovation in green technologies, create new green jobs and produce the kind of sustainable growth that will be the backbone of the 21st century economy. Asia can play a leading role in shaping this future.

I am pleased this Conference will consider policies, technologies and financing that can accelerate progress towards green industry in Asia. In doing so, you are making an important contribution to sealing the deal in Copenhagen. I wish you every success in your deliberations.

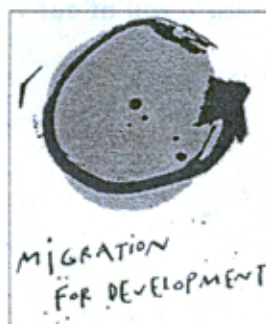

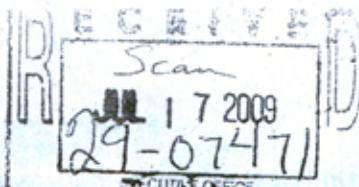

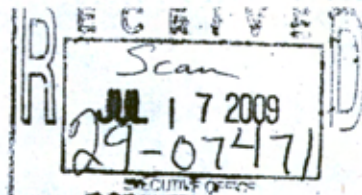
