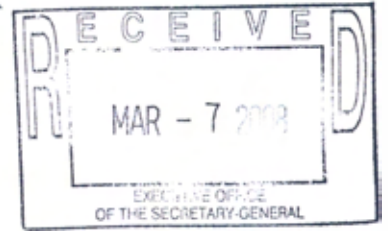

I am encouraged by your interest in the GNRC Third Forum, and hope you will give positive consideration to the invitation contained herein.

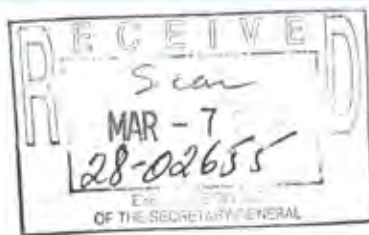
