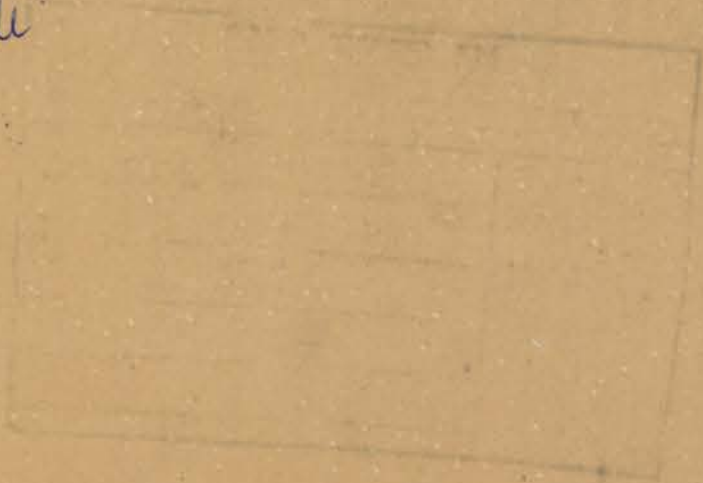

From: C.A. Gaviola, Chief of the Civil Mission, Bukavu.

Subject: Situation of distribution of flour from American donation ex Kampala.

With reference to the above mentioned subject, Mr. Nechaert established the attached report on the distribution of the American flour donation ex Kampala, received at Bukavu from Goma, as per dates and since the beginning of the authority granted by you to commercialize the balance of the donation to Licross Kampala.

We are taking the necessary steps to provide Albertville with a bulk quantity by the barge leaving Kalundu on 12 March and we will keep you informed accordingly. The delay is unfortunately beyond our control due to the deterioration of the Bukavu/Usumbura road which occurred in mid-February.

We would like to receive your confirmation regarding the points raised in our previous report and concerning mainly the payment of the transport fees Kampala/Goma and the arrangements made with Licross for a close study of Licross and ONUC responsibilities as regards the storage and the transport fees for the whole lot.

The total amount cashed from distribution by this Office is 1,788,006 C.F. not including the 52,500 C.F. representing the counter-value of the 70 bags air-lifted to Albertville, which would give a round figure of 1,840,506 C.F.

Mr. Jerkovic has shown me your memorandum of 19 Feb on the above subject. In this connection I would draw your attention to the purpose of the present airlift programme which is "to assist in the distribution of consumer goods to the interior" (see Field Administrative Report No. 31 Part A). In some cases, in order to achieve this object, it is desirable for the merchant concerned to accompany the goods. This also has the advantage of relieving ONUC of responsibility for safe arrival of goods.

When, under this arrangement, the merchant charts a whole plane, as in the case of Mr. and Mrs. Brookhuizen, it is hardly relevant to suggest, as you do, that their presence on plane would reduce appreciably the amount of merchandise carried. There is no question, however, of such persons having a "right to travel", nor does the question arise of our transporting passengers for payment, which as you point out, is contrary to IATA rules.

As regards the risk in which UN may be involved, this/ neither more nor less than that involved in the transportation of other non ONUC personnel. We require lists of merchandise being sent on ONUC planes, and the presence of the owners on the plane would not seem to increase the risk of illicit items being included.

I am not pressing the specific case of Mr. and Mrs. Brookhuizen, but would like to point out that other cases may arise in the future in which it is advisable for owners of merchandise to travel on ONUC planes carrying the latter.

While my impression is that space in U.N. planes will be made available as a special case for carrying consumer goods on a freight payable basis, it is difficult to make this agreement include the carrying of non-U.N. personnel in U.N. planes. If there is space available, it can be used for carrying more merchandise. The rate of 2 CF per pound per hour, you will agree has been worked out in the context of economic assistance to the various parts of the Congo and cannot be considered as a commercial rate. Just because the whole plane has been taken over by an individual on this basis, it does not give him the right to travel in these planes without payment of the normal airfare. Moreover, the IATA rules forbid us from transporting passengers on payment.

Another point which has struck us is the advisability of recognising their travel officially from the point of view of the risk the U.N. may be involved in cases of accidents, particularly as the entire merchandise in the plane belongs to the travellers as we may not normally be in a position to check whether the items being carried are in accordance with the regulations. I shall be grateful for your comments.

1. I refer to my memo dated 7 December 1962, concerning the same subject.
2. According to a photostat copy of letter signed by Minister J.P. Derikoyar, CAB/62-AEC, this flour should have been sold to the baker at "597 C.Frs. C.I.F., Albertville"
3. Accordingly we collected from Pereira, as stated in my memo of 7 December 1962, 1/976.667 C.Frs and we sent an unnumbered invoice dated 5 November 1962, from FONDS MWAMI MWAMBUTSA, to the amount of 34.446 Francs Burundi, to you for settlement by the United Nations.
4. Mr. Pereira has just brought to my attention that through his bank, Belge d'Afrique, Leopoldville, he was requested to pay the invoice for transportation by the FONDS MWAMI MWAMBUTSA.

Please find enclosed copy of the respective correspondence and Mr. Pereira confirms that he has already paid to the Banque Belge d'Afrique, the amount of 50.000 C.Frs to cover such transportation.

5. He now requests that this payment is re-imbursed to him for the following reasons:
- a) The invoice refers to flour shipment of 150 tons which was received from Usumbura to Albertville, at the end of October 1962;
 - b) This flour was to be charged to Mr. Pereira at 597 C.Frs C.I.F., Albertville. The payment has been effected by Mr. Pereira under these conditions;
 - c) Accordingly, Mr. Pereira maintains that the freight of flour before reaching Albertville should be borne by the United Nations, or by the Congolese Government;
6. I should greatly appreciate your early decision in this matter.
