Dear Miss Hosp:

It was perfectly alright for you to send me a copy of your letter to Colonel Lubbock.

I had an opportunity of discussing your proposal with Colonel Lubbock before he left. He pointed out - as I am sure you will agree - that it would be inappropriate for anyone to come to Greece for only four to six weeks in view of the difficulties of properly organizing the project to be of great value in so short a period. Also, even though you have a real point in suggesting that it would be easier to send a few specialists to Greece to train Greeks there, at the present time Colonel Lubbock believes the emphasis should be on securing fellowships for Greeks to take refresher work here or elsewhere.

We both appreciate your offer to be of assistance and we hope that through the AANH, some fellowships may be arranged for Greeks to study here.

In the midst of your very busy preparation for departure from the country, I hesitate to burden you with even one more matter. However, Dr. McHale suggested that I get in touch with you regarding my personal interest in the teacher training program in Greece.

Dr. McHale shared with me the notes taken at the very stimulating conference you held with members of our staff on March 20. You spoke of the need "for trained Greeks who would remain with the job long after the Allied specialist had gone home." In connection with that, the following statement impressed me particularly: "Colonel Lubbock recommended short-term courses for people already relatively well trained. People in Greece are sent abroad by UNRRA for as short a training period as two weeks, then they go back to the job."

Why not then, send to Greece, the specialist to give the short training course? In that way, more people could have the benefits of training.

Yes, I would like to apply as a specialist in the field of teacher training, which you designated as one for which there is particular need. I could be available for four or six weeks this summer.

Enclosed is a digest of my background. I qualify through study and experience for a post on various educational levels, -- the young child, the adolescent, and the adult. My work in personnel and in guidance programs of youth should be particularly useful.

I have had wide travel. And I know I would be very understanding of the prevailing conditions abroad.
