1. GENERAL SITUATION. GEN IS CALM BUT INCREASINGLY UNSTABLE DUE TO INCREASE IN BANDITRY AND THEATENING LTRS RECV BY LOC POP FROM RWANDA CRIMINALS IN ZAIRE . LOC IN THE KAGANO AND KIRAMBO AREA HAVE ASKED FOR ESTB OF A PROTECTIVE CAMP MANNED BY UNAMIT TROOPS AND HAVE INDICATED THAT THEY WOULD START MOVING TOWARD THE HOSPITAL AND THE ORPHANAGES IN THE AREA IF THE SECUR SIT DOES NOT IMPROVE. THIS IS SIGNIFICANT BECAUSE THE SITUATION IN THIS AREA IS NOT FORSEEN TO CHANGE FOR A LONG PERIOD OF TIME. ETHIOBAT COMD IN NYAMASHEKE AREA HAS AGREED TO PROVIDE TWO SOLDIERS TO ASST IN PROVIDING BETTER FIXED SECUR OF HOSP AND MILOB LOCATIONS IN NYAMASHEKE. INCIDENT. AT ISHARA PENINSULA AT 0100 HRS TWO BOATS SIGHTED AND ENGAGED BY RPA. FIRE WAS RETURNED AND BOATS WITHDREW BACK INTO DISTANT WATER . NO CAS REPORTED . AT KAVHUNE GR9740 AT APPROX 0100HRS A GP OF ABOUT 10 BANDITS ARMED WITH AUTO WPNS ROBBED HOME OF MAJEYAMBERI AND STOLE ALL GOODS. BANDITS WARNED OF THEIR RTN FOR LIVESTOCK. REGARDING THE APPROACHING DARE OF 6 APRIL, MANY NGO AND UN AGENCY PERS ARE BECOMING MORE CONCERNED OF THE SIT AND SECURITY PLANS.

2. FACTIONAL ACTIVITIES.

A. RPA.

(1) THERE WAS AN EXCHANGE OF FIRE NEAR RUZIZI TWO BETWEEN THE HRS 1000 AND HRS 1300 HRS 26 MARCH BETWEEN RPA AND ZAIRE SOLDIERS. THESE SOLDIERS ARE BASED NEAR THE CAMP OF PANZI (REFUGEE CAMP) AND ACCORDING TO PERS AT RUZIZI TWO THERE WERE CASUALTIES ON BOTH SIDE. IT IS NOT CFM, BUT IT APPEARS THERE WERE INJURIES ON ZAIRE SIDE AND TWO DEATHS ON RPA SIDE. DUE TO THE PROXIMITY TO THE CAMP, IT IS ALSO NOT CFM WHETHER FRGF ELMS MAY HAVE INSTIGATED OR PARTICIPATED IN ANY WAY IN THE INCIDENT.

(2) IT IS REPORTED THAT A PREGNANT ZAIREAN WOMAN WAS BEATEN BY RPA SOLDIERS AT RUZIZI TWO ON FRIDAY 24 MARCH. IT IS KNOWN HT AT SHE WAS ADMITED TO A BUKAVU CLINIC AND HAS SUBSEQUENTLY DIED. THE WOMAN ALLEGEDLY COULD NOT PAY AN AMOUNT OF MONEY DEMANDED BY THE SOLDIER UPON RE-ENTERING ZAIRE FROM RWANDA AFTER MARKETING IN CYANGUGU.

4. OWN ACTIVITIES. PATROLS CARRIED OUT IAW PATROL PLAN.

HEL RECCE COMPLETED ALONG RUZIZI RIVER BETWEEN BUKAVU AND BUGAREMA AND ALONG PART OF BURUNDI BORDER EAST OF BUGARAMA. ALONG RUZIZI RIVER NOTHING SIGNIFICANT WAS OBSERVED, NO OBVIOUS MILITARY CAMPS OR ANY MILITARY MOVT OF ZAIRE, RPA OR FRGF TROOPS/VEH. THERE ARE, HOWEVER, FACILITIES ALONG THE BANKS THAT WOULD WELL SUPPORT ANY SUCH ACTIVITY ON THE ZAIRE SIDE OF THE RIVER. IT WAS OBSERVED THAT RPA OBSERVATION POSTS AND TROOP PRESENCE IS SEVERELY LIMITED ALONG THE RUGGED BANKS, PARTICULARLY IN THE EAST AND SOUTHERN COMMUNE AREA. WHICH IS WHERE MUCH OF THE REPORTED CROSS BORDER MOVT HAS BEEN OCCURRING IN RECENT WEEKS.

A. 24 REFUGEES WAITING TPT FROM BUGAMA TO CYANGUGU.

B. HUMAN RIGHTS NEW TM MEMBERS RECV MILOB BRIEF OF PARTICULAR SIT IN NYAMAHEKE AREA BY MILOB TM LOC THERE.

C. INCREASE IN HUMAN RIGHTS TM MEMBERS HERE LACK OF DEDICATED VEH FOR HUMANITARIAN CELL HAVE SEVERELY LIMITED HAC ABILITIES IN 4C.

D. PREFET REPORTS THAT HE HAS HEARD OF ABOUT 100 RWANDAANS WHO HAVE CROSSED TO ZAIRE IN RECENT DAYS. UNHCR CYANGUGU CFM THAT UNHCR BUKAVU HAVE SEEN AN ADDITION TO CAMP POP IN RECENT DAYS.

6. LOGISTICS. WHAT IS STATUS OF OUR REQ FOR FUEL DRUMS AND JERRY CANS FOR MILOB TMS IN 4C. PLS CFM IF ANOTHER BASE SET AND ANTENNAIS AVAIL FOR A SECOND AND SEPRATE MILOB RESIDENCE LOC IN NYAMASHEKE AREA AS PREVIOUSLY REQ. THE TEAMS LOC HERE HAVE NO VEH AND ONLY ONE HANDHELD RADIO.

7. MISC.

A. COMMUNICATION ON CHANNEL 12 IS DIFICULT AND CONFUSING. IT HAS BEEN REPORTED TO YOU THAT DUE TO INCREASE IN USE AND ABUSE HAS MADE COMMS DIFFICULT AND THE MAINT OF THE REPEATERS ALSO COMPOUNDS THE SIT. WE HAVE ASKED FOR AN UPDATE OF C/S USING THE NET, BUT HAVE RECV NOTHING. THERE HAS BEEN A CHANGE IN SOME SECTORS AND THEIR C/S AND IT NOW SEEMS THAT SECTOR 2, 3 AND 4 ARE ON CHANNEL 12, WHICH INCLUDES ALL CIVPOL, HUMAN RIGHTS AND ALL CONVOYS IN THE AREA. WITH THE RECENT INCREASE IN HUMAN RIGHTS TMS AND C/S THE NET IS ALMOST IMPOSSIBLE TO WORK ON PARTICULARLY AT SITREP TIME. WHAT ARE THE COMM PLANS FOR WHO AND WHAT ARE ON CHANNEL ALLOC FOR UNAMIR MISSION, AND IS THERE ANY INPUT AND CONCERNS YOU WOULD REQ FROM THE SECTORS ?

1.GENERAL SITUATION.The general sit remains tense.there have been fresh incidents of robberies.there was a heavy exchange of fire at mubumba GR 3439 at 2330h on 25 march between the RPA and the bandits for a duration of 20 min.The bandits stole household good and foodstuff fsrom a house in the same area An incident of robbery was also reported at cyarukara GR 9005 ON THE NIGHT OF 25/26 MAR THE BANDITS STOLE HOUSEHOLD GOODS AND MONEY AND ALSO SHOT DEAD ONE3 PERSON BY THE NAME KENYESHYAMBA AND WOUNDED ANOTHER . THE WOUNDED WAS BROUGHT TO THE CYANGUGU HOSPITAL BY THE MILOBS . THE LOCALS IN THE AREA OF NYAMASHEKA ARE FECLING SCAARED AND TWO PERSONS HAD REQUESTED REFUGE WITH THE MILOBS TODAYTHE TEQUEST WAS HOWEVER DENIED.

2. FACTIONALL ACTIVITIES.

A. RPA. THE RPA SHOT DEAD TWO WOMEN AND TWO MEN, ONE OOF THEM AN OLD MAN OF SIXTY THE AREA OF NYAMASHEKE . THESE PEOPLE WERE SHOT BETWEEN 1930 AND 2030 ON MAR . 1. GENERAL SITUATION. THE GENERAL SIT REMAINS TENSE. THERE HAVE BEEN FRESH ROBBERIES AND KILLINGS IN THE AREA OF NYAMASHEKE. IN FACT IT HAS BECOME A MATTER OF ROUTINE. THE KILLING AND ROBBERIES ARE ABLE TO OPERATE WITHOUT MUCH HINDRANCE. THERE ARE UNCONFIRMED REPORTS THAT THERE HAS BEEN A REVERSE FLOW OF REFUGEES TO ZAIRE IN THE RECENT DAYS. THE MATTER IS UNDER INVESTIGATION.

IN GASHONGA GR 8212 TWO WOMEN WERE ABDUCTED AND PRESUMABLY TAKEN TO ZAIRE BY UNKNOWN PERS. THE NAMES OF THE WOMEN ARE NYIRATIBIRAMIRA AND ANNONCIATA. ONE PERSON BY THE NAME OF BENJAMIN GATETE (TUTSI) WAS ALSO KILLED IN THE SAME AREA (GASHONGA). HE WAS KILLED WITH MACHETE IN THE LEGS AND TORSO AT APPROX 0300 HRS 16 MARCH AND HAD RETURNED FROM ZAIRE IN SEPTEMBER AND WAS RESIDING IN THE FORMER HUTU HOUSE. A REPORT WITH MORE DETAIL AND THEORIES WILL BE FWD WHEN MORE INFO AVAIL. THE DETAILS OF THE OTHER INCIDENTS ARE BEING GIVEN IN THE RELEVANT PARAGRAPHS BELOW.

IT IS PRESUMED THAT THE THIS IS AN ACT OF VENGEANCE ON THE PART OF RPA. THE DECEASED WAS A FRIEND OF THE RPA SOLDIERS WHO USED FREQUENT HIS HOUSE.
