Please accept, Excellency, the assurances of my highest consideration.

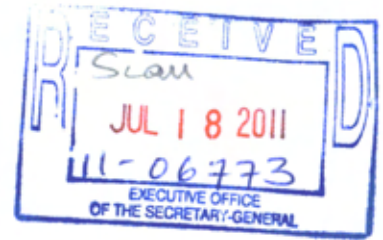

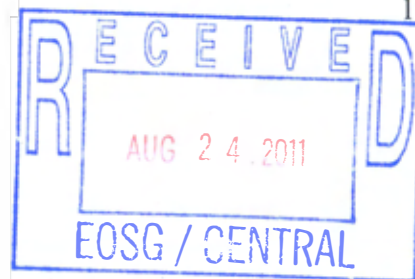

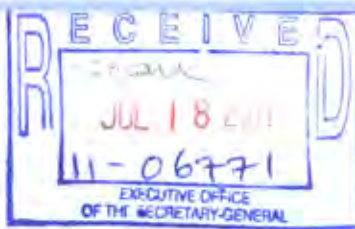

I have the honor to inform you that I will conclude my tenure as Ambassador Extraordinary and Plenipotentiary, Permanent Representative of the Dominican Republic to the United Nations, effective from 13<sup>th</sup> July 2011. Pending the arrival of my successor, H. E. Mr. Luis Lithgow, Alternate Permanent Representative, will take charge of the Mission.

To represent my country during these 26 months made possible the immense privilege of meeting you and to collaborate on so many issues of the international agenda: the promotion of Haiti and of Least-Developed Countries, food and nutritional security, Millenium Development Goals, preventing and mitigating natural disasters, gender equality and transitioning to renewable energy sources for adaptation to climate change.

Having achieved the election of my country to the ECOSOC and to the Executive Board of UN Women were important landmarks that crowned my tenure and that will receive the continued and committed quality work of my colleagues.

On this occasion, however, I must thank you most specially for the wealth of knowledge, culture and experience you were able to convey to me, which I will treasure as the most valuable memory of my transit through this diplomatic post so plentifull of colleagues of high personal and professional standing.

It is on this note that I leave for my new duties as Ambassador Extraordinary and Plenipotentiary of the Dominican Republic to the United Kingdom of Great Britain and Northern Ireland, in the certainty that the same friendly relationship between my Mission and your organization will continue and be further strengthened in the future.
