5. HUMANITARIAN AFFAIRS. THE TEAM AT OP RUBY REPORTED THAT ABOUT 100 PERSONS FROM BURINDI WERE WAITING AT AKABUGA BC 499887 FOR CROSSING INTO RWANDA TO ATTEND THE KAMANA 5196 MARKET. PRESENCE OF RPA SOLDIERS PREVENTED THEM FROM CROSSING. THERE WERE UNCONFIRMED REPORTS CIRCULATING IN KAMANA CAMP THAT ABOUT 7000 IDPs FROM THIS CAMP HAD CROSSED INTO BURINDI IN THE LAST TWO WEEKS.

6. CIVILIAN AFFAIRS. CONSISTENT REPORTS AT KIBEHO AND NDAGO INDICATE THAT THE SPEECH OF THE VICE-PRESIDENT OF RWANDA LAST WEEK HAD A NEGATIVE IMPACT ON THE MORALE AND THE MOOD OF THE DPs IN THE CAMP. THERE IS A GROWING CONCERN AMONGST THE DPs NOT TO RETURN TO THEIR HOME COMMUNES BUT INSTEAD FLEE TO BURINDI.


