a. SECTOR HQ. Normal morning briefing was held at 0800 hrs.

5. Sec Comd attended meeting with head ICRC Kibungo and members of Human Rights. He was informed that the transfer of prisoners of the 11 Communes Caches of the Prefecture to Kibungo main prison is planned to be carried out commencing Mon 04 Dec. Approximately eleven (11) days are needed for this operation to shift more than 2,000 prisoners to this location. Official request to assist with transport from UNAMIR will be forwarded shortly. In the meantime, cleaning - , disinfection - and minor repair work will be carried out at mentioned location. So far, cache prisoners are provided with food stuffs from their relatives, after the transfer to main prison Kibungo ICRC will take care of their feeding. Exact figures and the concept of the operation will be issued by ICRC next week.

THERE ARE 37 PRISONERS IN THE COMMUNE CACHOT OUT OF WHICH 30 ARE ACCUSED OF GENOCIDE. THE CONDITIONS IN THE PRISON ARE SATISFACTORY. THE BOURGMASTRE IS CARRYING OUT RECONCILIATORY RALLIES IN THE COMMUNE. THE BOURGMASTRE REQUESTED FOR ASSISTANCE IN CONSTRUCTION OF 1200 HOUSES FOR THOSE WHOSE HOUSES WERE DESTROYED AND WERE LIVING IN MAKESHIFT HOUSES.
