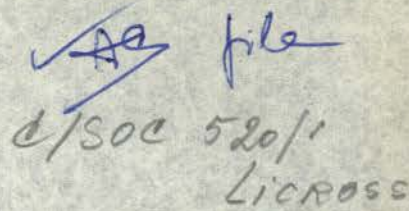

Gasoline for Stanleyville

..... From the exchange of telegrams attached you will see that the Minister of Economic Affairs has granted a request from the League of Red Cross Societies to allow the delivery of 20 drums of gasoline to Stanleyville for Red Cross purposes. Mr. Tickner refuses to accept this exceptional arrangement and wishes us to insist that Mr. Dericoyard lift his general ban on the supply of gasoline to Orientale province as a condition of Mr. Tickner's agreeing to arrange passage for the 20 drums for the Red Cross.

In my view Red Cross supplies should never be used as political levers. Moreover, if the League delegate here informs the League in Geneva that ONUC is obstructing a *Red Cross* delivery which has been agreed by the responsible minister there would be an immediate protest to the Secretary General.

On the other hand I think we should lose no opportunity to impress on Mr. Dericoyard the gravity of the consequences of his refusal to allow supplies of gasoline and oil to move to Stanleyville.

This is a matter you will probably wish to take up on the political side. I shall be glad to have your instructions in due course.
