Please accept, Mr. Ambassador, the assurances of my highest consideration.

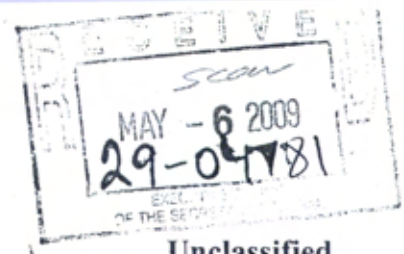
