1. FURTHER TO CLEAR LU-125 PARA 2 AM INFORMED THAT ABBE ATHANASE AT PRESENT IN LEO IS REGARDING SENATE VOTE AS HAVING SETTLED STATUS OF CEC AND TOWN OF LUSAMBO IN FAVOUR OF SANKURU. IT IS THEREFORE WORTH STRESSING AAA THAT DRAFT LAW IN QUESTION ONLY CONCERNS SECTORS OF KINDUYI, ELKA, MIALABA AND KASHINDI HITHERTO PART OF TERRITORY OF LUSAMBO BELONGING TO LOMAMI WHICH ACCORDING TO THIS BILL IS TO BE SUBJECT TO REFERENDUM. BBB THIS IS AYE DRAFT LAW (PROJET DE LOI) REQUIRING VOTE OF CHAMBER OF REPRESENTATIVES AND PROMULGATION BY CHIEF OF STATE BEFORE HAVING FORCE OF LAW.
2. CONFUSION HAS BEEN CAUSED BY WORDING OF FINAL TEXT OF BILL AS PASSED BY SENATE IN WHICH REFERENCE TO STATUS OF CEC OF LUSAMBO IN EXPOSE DES MOTIFS IS IN CONTRADICTION WITH REFERENCE TO SAME AREA IN ARTICLE ONE OF THE BILL ITSELF. REFERENCE IN EXPOSE DES MOTIFS IS QUOTE VU QUE LE TERRITOIRE DE LUSAMBO, SAUF LE SECTEUR DES BATETELA ATTACHE A LA PROVINCE DU NORD SANKURU ET LE CENTRE EXTRA-COUTUMIER QUI EST SOUMIS AU REFERENDUM, A ETE INCINS A LA PROVINCE DE LA LOMAMI UNQUOTE. ARTICLE ONE AS FOLLOWS QUOTE A L'EXCEPTION DU SECTEUR DES BATETELA, CENTRES EXTRA-COUTUMIER ET URBAIN QUI APPARTIENNENT A LA PROVINCE DU SANKURU, LES SECTEURS DE KINDUYI - ELKA - MIALABA ET KASHINDI SONT SOUMIS AU REFERENDUM UNQUOTE. OBVIOUSLY STATUS OF CEC DESCRIBED IN EXPOSE DES MOTIFS IS THE CORRECT ONE. ABBE ATHANASE SEEMS TO HAVE WASTED NO TIME IN EXPLOITING THIS CONFUSION.



Received visit today from Otshudiandjeka Joseph, representing Abbé Athanas, accompanied by Pasteur Schaffert of Entr'Aide Protestante to discuss refugees from Lodja. Joseph asked ONUC help transportation twenty thousand refugees from Lodja to Katako Kombe, also food and medical supplies. Recalling your LUPOL-45, I discouraged further movement refugees, mentioning our greatly reduced means transportation. However, would welcome your advice any need our help refugees already at Katako Kombe. Entr'Aide Protestante ready provide some medical supplies including anti-malarial drugs, also flour and milk if deemed necessary. In that case we would examine possibility help with transportation. Appreciate reply soonest.

1. IN LAST-MINUTE CHANGE IN PROGRAMME FOR INDEPENDENCE CELEBRATION, CONGO GOVERNMENT ANNOUNCED YESTERDAY 27 JUNE THAT KASA-VUBU WOULD HOIST NEW CONGOLESE FLAG FOR FIRST TIME ON 30 JUNE 9.45 a.m.
2. DRAFT LAW ON COAT OF ARMS, MOTTO AND EMBLEM OF REPUBLIC PASSED BY CHAMBER ON 22 MARCH AND BY SENATE ON 25 MARCH, BUT NOT REPEAT NOT YET SIGNED BY CHIEF STATE. IN REPLY TO OUR QUERY, KASA-VUBU'S OFFICE INFORMED THAT LAW WILL BE SIGNED SOONER, PROBABLY THIS AFTERNOON 28 JUNE.
3. LAW AS ADOPTED BY PARLIAMENT BEARS QUOTE LOI FIXANT LES ARMOIRIES, LA DEVISE ET L'EMBLEME DE LA REPUBLIQUE DU CONGO, ARTICLE 1ER: LES ARMOIRIES DE LA REPUBLIQUE DU CONGO SE COMPOSENT D'UNE TOUR DE LEOPARD ENCAISSÉE (A GAUCHE) D'UNE BRASURE DE PALMIER ET D'UNE FLEUR (A DROITE) D'UNE POINTE D'IVOIRE ET D'UNE LANCHE, LE TOUT REPOSANT SUR UNE PIERRE, ARTICLE 2: LA DEVISE EST: "UNITE, JUSTICE ET TRAVAIL". ARTICLE 3: SON EMBLEME EST LE DRAPEAU BLEU-CIEL ORNE D'UNE BOUTEILLE JAUNE DANS LE COIN SUPERIEUR GAUCHE ET TRAVERSE EN BAS D'UNE BANDE NOIRE FINEMENT ENCADRÉE DE JAUNE. 4. NORMALLY ALL OLD FLAGS SHOULD BE REPLACED BY NEW ONES AFTER THE HOISTING CEREMONY. UNFORTUNATELY AS INDEED EVERYONE ELSE INCLUDING CONGOLESE AUTHORITIES HAVE BEEN CAUGHT OFF GUARD BY GOVERNMENT'S DECISION. WE HAVE NOT REPEAT NOT BEEN ABLE TO GET ENOUGH NEW FLAGS FOR DISTRIBUTION TO ALL OUR OFFICIAL BUILDINGS. WE ARE TAKING URGENT MEASURES TO THAT EFFECT. MEANWHILE SUGGEST YOU CONSULT WITH LOCAL REPRESENTATIVES OF CENTRAL GOVERNMENT REGARDING ARRANGEMENTS FOR CHANGE OF FLAG YOUR AREA.

1. SENATE HAS VOTED APPROVAL OF REPORT OF SENATORIAL COMMISSION WHICH VISITED LULUABOURG DURING BREAK IN SENATE'S PROCEEDINGS BETWEEN 26 APRIL AND 15 MAY RECOMMENDING SPECIAL SESSION OF PROVINCIAL ASSEMBLY TO ELECT AYE "LEGAL BUREAU", RULE ON THE CASES OF INCOMPATIBILITY OF FIVE COUNCILLORS (MESSRS BADIYAKE, KABULA, TSHIMANGA, MUKOLO AND BADIYANGA-TSHIKELE) AND CONFIRM LEGALITY OF PRESENT GOVERNMENT OR ELSE ELECT A NEW ONE. SENATORIAL COMMISSION SUPPORTS REPORT OF COMMISSION VALIDATION DES POUVOIRS OF 24 DECEMBER ESTABLISHING INCOMPATIBILITY OF FIVE ABOVEMENTIONED COUNCILLORS. THIS IS SIMPLY AYE RECOMMENDATION AND IT IS NOT YET KNOWN WHAT ACTION (IF ANY) WILL BE TAKEN BY MINISTER OF INTERIOR MABOTI.

2. SENATE ALSO VOTED REPORT OF ANOTHER SENATORIAL COMMISSION SENT TO LUSAMBO DURING SAME PERIOD WHICH INCLUDES DRAFT LAW CONCERNING TERRITORY OF LUSAMBO AT PRESENT FORMING PART OF LOMAMI (IE NOT THE BATETELA PART ATTACHED TO SANKURU NOR THE CEC OR TOWN OF LUSAMBO WHICH IS SUBJECT TO REFERENDUM). AREA IN QUESTION ACCORDING TO ABOVE DRAFT LAW IS TO BE SUBJECT TO REFERENDUM BETWEEN LOMAMI AND SOUTH KASAI. THIS IS RECOMMENDED AS AYE RESULT OF PETITIONS OF THE BABINDI-BAMBU. VOTING ON DRAFT LAW WAS 28 FOR, 32 AGAINST, 9 ABSTENTIONS. IT HAS NOW TO GO BEFORE CHAMBER OF REPRESENTATIVES, BUT AS PARLIAMENT HAS

NOW BEEN RECESSED TILL 2 SEPTEMBER, IT CAN BE REGARDED AS SHELVED FOR TIME BEING.

3. THIRD SENATORIAL REPORT CONFIRMING MWENE DITU AS REFERENDUM AREA AND CALLING FOR ARRANGEMENTS TO HOLD REFERENDUM HERE AND IN OTHER CONTESTED AREAS SOONEST WAS SUBJECT OF STORMY DEBATE BUT WAS EVENTUALLY PUT ASIDE FOR CONSIDERATION NEXT SESSION.

4. AT SAMETIME, CHAMBER OF REPRESENTATIVES HAS BEEN DISCUSSING REPORT OF THEIR PARLIAMENTARY COMMISSION TO SOUTH KASAI WHICH EXPRESSES SUPPORT FOR NGALULA GOVERNMENT CONDEMNING KALONJI JEUNESSES ETC. IN VIEW OF ALLEGATIONS THAT SOME MEMBERS OF THE COMMISSION WERE BRIBED AND QUARREL THAT SUBSEQUENTLY BROKE OUT BETWEEN MEMBERS OF COMMISSION ITSELF, HOUSE DECIDED TO APPOINT NEW COMMISSION TO ACCOMPANY MINISTER OF INTERIOR MABOTI TO BAKWANGA IN NEAR FUTURE.

IN SENATE YESTERDAY CELESTIN LUNYASSI, SECRETARY OF STATE AT MINISTRY OF INTERIOR WAS SUMMONED TO ANSWER QUESTIONS ON SITUATION IN NEW PROVINCE OF SANKURU BRACKET EX-KASAI UNBRACKET TABLED BY SENATORS TCHAHÉ-OTCHOUDY BRACKET MNC-L UNBRACKET AND DIUMI BRACKET MNC-L UNBRACKET. LUNYASSI WHO HAS RECENTLY RETURNED FROM THIS AREA WHERE HE WAS CONDUCTING AN ENQUIRY INTO INCIDENTS THERE, WAS CRITICIZED FOR HAVING TAKEN SIDES AGAINST THE LEGALLY INVESTED PRESIDENT DIUMASUMBU, OF HAVING BROUGHT HIM BACK TO LEO UNDER ARREST AND OF HAVING DECREED MARTIAL LAW IN THE PROVINCE. IN REPLY, LUNYASSI POINTED OUT THAT WARRANT FOR ARREST OF DIUMASUMBU WAS ISSUED BY LULUABOURG PARQUET, THAT IN FACT DIUMASUMBU HAD BEEN GUILTY OF FORMING HIS OWN JEUNESSE WHO FOMENTED DISORDERS ETC. NO VOTE HAS TAKEN AS PROCEEDINGS TOOK FORM OF PARLIAMENTARY QUESTION NOT AYE CENSURE MOTION. HOWEVER GENERAL OPINION OF THE HOUSE WAS SEVERELY CRITICAL OF SECRETARY OF STATE.
