The attached cable from the Secretary-General of the Somali National League should, in my opinion, be submitted for inclusion in the "Review of Communications Received Relating to General Assembly Matters". It comes from a political organization which is quite powerful in the British Protectorate of Somaliland and which raises an issue of policy well known to the United Kingdom authorities.

My above recommendation is also based on the fact that it is directly related to the agenda of the Thirteenth Session of the General Assembly both in relation to Non-Self-Governing Territories and Trusteeship.
