I write to acknowledge, with thanks, your letter dated 14 July 2010, in which you requested a meeting between the Secretary-General and His Excellency Mr. Dimitris Christofias, President of the Republic of Cyprus, between 19 and 26 September 2010.

The period during the opening of the sixty-fifth session of the General Assembly, the High-level Plenary Meeting on the Millennium Development Goals and the General Debate will be an extremely busy time for all parties. Be assured that your request was brought to the attention of the Secretary-General. However, we are still receiving information about numerous meetings and events relating to the session that will require the Secretary-General's presence. It is therefore not possible to determine how much time will be available for bilateral meetings until closer to the opening of the General Debate.

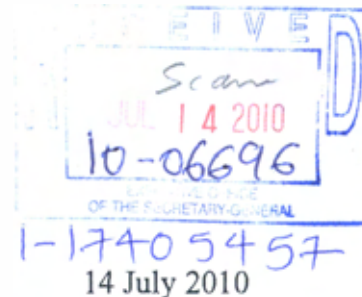
