SECRET ELLEO 235 LINNER FROM IVAN SMITH

WE ARE ENDEAVOURING TO RENT A LARGE HOUSE WITHIN THE HQ PERIMETER TO HOUSE CIVILIAN STAFF. OWNER WAS WILLING BUT RELUCTANT IN CASE IT CREATED COMPLICATIONS WITH GOVERNMENT. EYE SENT SUCCAR TO MAKE SHORT FRIENDLY AND INFORMAL CALL ON KIMBA TO PRESENT MY COMPLIMENTS AND THANK HIM AGAIN FOR HIS PERSONAL HELP THE OTHER NIGHT AND MENTION INCIDENTALLY THAT IT WOULD ASSIST US IF HE WOULD REASSURE THE OWNER OF THE HOUSE. HE IMMEDIATELY WROTE AN ATTESTATION AS PRESIDENT AD INTERIM SAYING THEY HAD NO OBJECTION. AT THE END OF THE INTERVIEW HE SAID

Y WERE GOING TO TRY TO GET TSHOMBE BACK BEFORE HE LEAVES FOR BRAZIL "BECAUSE WE NEED HIM HERE". HE ALSO SEEMS TO RECOGNIZE THAT ULTRA OR MERCENARY ELEMENTS ARE LIKELY BEHIND THE INCIDENTS THE OTHER NIGHT WORKING UP AND USING THE AFRICANS IN AN ATTEMPT TO PROVOKE A CLASH BETWEEN UN AND AFRICANS. IN OTHER CONVERSATIONS WHICH EYE HAVE HAD WITH CONSULS AND WELL-INFORMED CORRESPONDENTS IT IS CLEAR THEY TOO SUSPECT THE HAND OF A SMALL BUT VERY EFFECTIVELY ORGANIZED BAND OF EXTREMIST MERCENARIES BEHIND RECENT EVENTS. I CORRESPONDENT BELIEVES THAT THE WHITE MAN WHO DROVE OUR CAR AWAY FROM SQUARE UVIRA WAS 1 OF THE RING AND THAT THE ONLY REASON THEY DID NOT PURSUE THEIR HOSTAGE PLAN WITH BRIAN WAS THAT THEY HAD TANGLED UP WITH THE DODD PARTY AND IT HAD BECOME TOO HOT: SO THE AFRICANS WERE LEFT TO GET OUT OF IT

AS BEST THEY COULD. SOME OBSERVERS BELIEVE THAT THE OTHER INCIDENT WAS STAGED A FEW HOURS LATER TO COLLECT ANOTHER HOSTAGE. WE KNOW NOW THAT THE JEEP WAS WAYLAID IN MUCH THE SAME WAY AS OUR CAR - A CROWD OF AFRICANS IN THE ROAD, A FRACAS AND THEN AT A CERTAIN POINT SOME (RESPONDENT BELIEVED 1 OR 2 MERCENARY ELEMENTS EMERGED FROM THE SHADOWS AND TOOK OVER. BRIAN AND EYE ARE IN THE MIDST OF MAKING AS MANY CONTACTS AS WE CAN WITH CONSULS: BUSINESS LEADERS AND MINISTERS TO DEVELOP A SENSE OF CALM AND QUIET TO OFFSET ELEMENTS OF PANIC AMONG SECTIONS OF THE POPULATION WHO WANT TO LEAVE EVILLE AND OTHERS WHO ARE BEING WORKED ON BY INFLAMMATORY PROPAGANDA. SECRET [ELLEO 229] LINNER FROM IVAN SMITH

[FURTHER TO MY ELLEO 223. IT WAS ACTUALLY DIFFICULT TO DISCOVER IN EVILLE WHETHER OR NOT TSHOMBE HAD LEFT. AT 6 PM US CONSUL DID NOT KNOW. AT 6.30 PM EYE CALLED ON BRITISH CONSUL WHO IMMEDIATELY INFORMED ME THAT TSHOMBE HAD LEFT AT 1 PM FOR A MORAL REARMAMENT CONFERENCE IN BRAZIL. EARLY IN THE DAY EYE HAD HEARD FROM A RELIABLE NEWSPAPERS CORRESPONDENT THAT THE VISIT WAS ALSO CONNECTED WITH AN ATTEMPT TO GET SOUTH AMERICAN FINANCIAL SUPPORT AND POSSIBILITY OF POLITICAL RECOGNITION OF KATANGA. QUESTION OF FINANCIAL SUPPORT HAS INTRICATE IMPLICATIONS. IT IS SAID HERE THAT THE SWISS ADVISERS WHO RETURNED WITH TSHOMBE AFTER HIS RECENT VISIT TO GENEVA ARE IN THE VIEW OF LOCAL INDUSTRIAL INTERESTS SAID TO BE MAKING AN OFFENSIVE ON BELGIAN FINANCIAL INTERESTS HERE. MY OWN TALKS WITH UNION MINIERE REFLECT THAT POSSIBILITY. IT IS ALSO INDICATED THAT THE BELGIAN FINANCIAL INTERESTS ARE REPRESENTED BY MR VAN ROYE WHO WAS EXPELLED BY US AS A POLITICAL ADVISER UNDER PARA A-2. HE RETURNED ABOUT 2 WEEKS AGO TO ELISABETHVILLE AND] WAS SAID TO BE THE DIRECTOR OF THE BANQUE NATIONALE DU CONGO. HIS JOB PREVIOUSLY AND UP TO TODAY HAS BEEN TO CONTROL THE DISPOSITION OF FOREIGN CURRENCIES. THERE SEEMS TO HAVE BEEN A MOVEMENT TO BRING THE BANQUE UNDER A DISCIPLINE THAT

WOULD FAVOUR KATANGESE RATHER THAN BELGIAN INTERESTS AND IN THAT CONNECTION IT IS INTERESTING TO NOTE THAT ONE OF THE DIRECTORS PROPOSED UNDER THE NEW SET UP WAS THE BELGIAN ETIENNE WILLAME (SEE MY ELLEO 228) WHO WAS THE ONLY OTHER PERSON DRAGGED OUT FROM SHERIDAN SMITHS HOUSE THE OTHER NIGHT WITH BRIAN URQUHART AND MYSELF AND BEATEN. WHILE URQUHART AND EYE WERE AT THE US CONSULATE RECEPTION PRECEDING THE INCIDENT AT SMITH HOUSE, VAN ROYE CAME UP TO US AND INTRODUCED HIMSELF OSTENTATIVELY. WE TREATED HIM WITH COOLNESS PARTICULARLY WHEN HE BEGAN TO DISCUSS THE REFUGEES QUESTION. EYE ASKED HIM HOW THIS ENTERED IN HIS BANKING BUSINESS AND HE SAID THAT HE WAS INTERESTED BY VIRTUE OF HIS ROLE AS AN OFFICIAL OF THE RED CROSS.
