The Secretary-General has seen the note and I am happy to confirm the meeting has been scheduled for Monday, 9 November 2009 at 4:00-4:20pm.

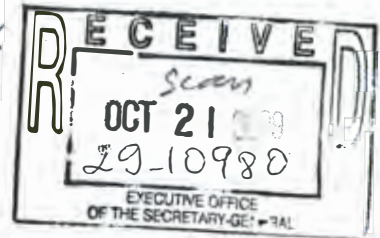
