Excellency,

We, the Permanent Representatives of the Gulf Cooperation Council (GCC) member states to the United Nations, condemn in the strongest terms the terrorist bomb attack which claimed the lives of three policemen and injured others earlier today in the Kingdom of Bahrain.

In rejecting all forms of terrorism targeting Bahrain's stability and security, we stand in solidarity with the Government and the people of Bahrain in the face of terrorism and blind violence. We take this opportunity to thank and commend the policemen and women of the GCC countries that give their support and their lives to the stability of the Kingdom of Bahrain and the region.

This senseless and cowardly act is prohibited by all religions and incriminated by all laws as it terrorized peaceful civilians and targets the security and stability of a member state of the GCC. We reaffirm, unequivocally, that the security of the Kingdom of Bahrain is an integral part of the security of the GCC and its member states and that any threat to its safety and integrity constitutes a threat to all.

We appreciate the statement of condemnation of the terrorist bomb attack issued by Your Excellency on 03 March, and we reiterate the message that such acts of violence cannot be justified by any cause. Pursuant to Your Excellency's longstanding policy of firmly condemning terrorism in all its forms, we trust that your office will continue to give due attention to this serious matter and reaffirm the United Nations' position in combatting terrorism wherever it is perpetrated.


