KIMBA'S LETTER RAISES QUESTION OF AUTHORITY TO CONTROL TRAFFIC OF GOODS WITHIN THE CONGO. WE CANNOT ACCEPT KATANGA'S CLAIM TO EXERCISE SUCH AUTHORITY WHICH IS LAWFUL PREROGATIVE OF CENTRAL GOVERNMENT. YOUR REPLY TO KIMBA MIGHT BE GOOD OPPORTUNITY TO DRAW THE LINE AND TO MAKE IT CLEAR TO THE KATANGESE THAT WE DO NOT ENTERTAIN ANY THOUGHT OF RECOGNIZING AS REPOSING IN THEM, DE FACTO OR DE JURE, ANY AUTHORITY WHICH PROPERLY BELONGS TO CENTRAL GOVERNMENT. WE DO NOT QUITE FOLLOW THE CALCULATION ON NUMBER OF INCOMING KATANGESE TROOPS IN YOUR PARA 1 (e), BUT IF YOU FEEL THIS INFLUX JUSTIFIES CHANGE FROM POSITION EXPRESSED IN EV 758 (G-741) AND G-730 WE AGREE YOUR INSTRUCTING GOC KATANGA AREA TO REFUSE KIEMBE'S REQUEST FOR INDUCTION OF ADDITIONAL TROOPS. ASSUME THIS WOULD MEAN THAT NO TROOPS WOULD BE BROUGHT INTO EVILLE FROM OTHER AREAS. SUGGEST YOUR CONSIDER ALLOWING TOKEN REPRESENTATIVE FORCES TO BE BROUGHT IN FROM OTHER AREAS.

AT MEETING THIS MORNING WITH REPRESENTATIVES OF BELGIUM, US, UK AND FRANCE OUR CONCERN AT INDUCTION OF ADDITIONAL TROOPS WAS EXPRESSED AND THEIR ASSISTANCE ASKED IN DISSUADING KATANGESE AUTHORITIES FROM THIS MOVE. CONSULS MIGHT BE INFORMED BY BACK PRIOR TO GOC'S COMMUNICATION OF REFUSAL TO KIEMBE. UNQUOTE

YOU RECALL THAT THIS REFLECTS MY ~~MENTION~~ TO THE PROPOSALS FROM E'VILLE WHICH YOU AND EYE DISCUSSED HERE. YOU WILL ALSO NOTE THAT THE REFUSAL IS EXPECTED TO COME NOT FROM ONUC BUT FROM CENTRAL GOVT. 




