1. REFERENCE DISCUSSION BETWEEN JACOBS AND ROEFFEN IN EVILLE LAST WEEK ON QUESTION OF DEALING WITH INDIVIDUAL CASES EVACUATED FROM KATANGA TO LEO FOR VARIOUS REASONS. HENCEFORTH ALL COMMUNICATIONS CONCERNING EVACUATION OR TRAVEL OF CONGOLESE FROM KATANGA TO LEO FOR REASONS SUCH AS FEAR OF PERSECUTION, SCHOLARSHIPS, EMPLOYMENT, FAMILY REUNION ETC. SHOULD BE ADDRESSED EXCLUSIVELY TO AHMED, JERKOVIC, CIVILIAN OPERATIONS, AND NOT TO ANY OTHER OFFICE AT LEO HQ. ONLY EXCEPTIONS ARE CASES OF INDIVIDUALS EVACUATED FROM KATANGA FOR FEAR OF REPRISAL FOR INFORMATION GIVEN TO UNATIONS. THESE CASES WILL BE HANDLED BY MR GARDINER'S OFFICE BUT CARE SHOULD BE TAKEN AT YOUR END NOT TO ALLOW CHARLATANS TO SWELL RANKS OF THIS CATEGORY OF PROSPECTIVE TRAVELLERS. IN PAST THERE HAVE BEEN DOUBTFUL CASES. THESE SHOULD BE DETECTED AND RESTRAINED.
2. ON ARRIVAL IN LEO, EVACUEES WITH SPECIAL PROBLEMS WILL BE DEALT WITH BY JERKOVIC, CIVILIAN OPERATIONS, WHO WILL PUT THEM IN TOUCH WITH OTHER SECTION OF ONUC IF NECESSARY. EXCEPTIONS AS ABOVE CONCERN ONLY PERSONS EVACUATED FOR FEAR OF REPRISAL FOR INFORMATION GIVEN OR OTHER REASONS OF EXCEPTIONAL POLITICAL IMPORTANCE.
3. IN ORDER TO AVOID CONFUSSION AT THIS END, GRATEFUL YOU MAKE QUITE CLEAR TO PROSPECTIVE TRAVELLERS THAT ONUC PROTECTION AND EVACUATION FROM EVILLE DOES NOT REPEAT NOT INCLUDE OR IMPLY PROMISE OF EMPLOYMENT BY ONUC ON ARRIVAL IN LEO

Quote THE BOARD OF ENQUIRY INTO THE CRASH OF 20 SEPTEMBER HAS COMPLETED ITS WORK. THE FULL TEXT OF THE REPORT OF THE BOARD, WHICH WE ARE INFORMED IS QUITE LONG, HAS NOT YET BEEN RECEIVED AT HEADQUARTERS. THE FOLLOWING, HOWEVER, IS A SUMMARY OF ITS FINDINGS. PARA. THE UNITED NATIONS DC-3 WAS FLYING STRAIGHT AND LEVEL ON A RECONNAISSANCE FLIGHT AT AN ALTITUDE OF 2600 TO 3000 FEET. THE PLANE WAS FIRED ON FROM GROUND AND AS A RESULT OF THE FIRE ONE MAN WAS KILLED, ONE BADLY WOUNDED AND ONE SLIGHTLY WOUNDED IN THE AIR. DUE TO FAILURE OF THE PORT ENGINE AND AILERON DAMAGE, THE PILOT MADE A CONTROLLED FORCED LANDING. AFTER LANDING, THE AIRCRAFT CAUGHT FIRE AND WAS ALMOST COMPLETELY DESTROYED. THE CREW EVACUATED THE WOUNDED AND THE BODY OF THE DEAD MAN AND LEFT THE AIRCRAFT. AT THIS POINT THE CREW CAME UNDER FIRE FROM ANC TROOPS IN THE VICINITY, WHO WERE UNDER THE IMPRESSION THAT THE CREW WERE MEMBERS OF THE KATANGESE FORCES, BUT SUFFERED NO FURTHER CASUALTIES. THREE CREW MEMBERS ESCAPED INTO THE BUSH, AND THE REMAINDER, TOGETHER WITH THE WOUNDED AND THE BODY OF THE DEAD MAN, WERE TAKEN INTO CUSTODY BY ANC SOLDIERS WHO TOOK THEM TO ALBERTVILLE FROM WHERE THEY WERE AIRLIFTED TO KAMINA. THE THREE CREW MEMBERS WHO ESCAPED INTO THE BUSH WERE PICKED UP BY UN HELICOPTERS LATE IN THE AFTERNOON ON THE FOLLOWING DAY AND BROUGHT TO KAMINA. ONE OF THE WOUNDED DIED APPROXIMATELY FIVE HOURS AFTER THE ACCIDENT. PARA. THE BOARD OF ENQUIRY MADE AN EXHAUSTIVE INVESTIGATION AT THE SITE OF THE CRASH AND ALSO FLEW OVER THE SITE ON EXACTLY THE SAME COURSE AND AT THE SAME HEIGHT AS THE CRASHED

AIRCRAFT. IT WAS ESTABLISHED THAT BOTH ANC AND KATANGESE GROUND FORCES WERE IN THE AREA AT THE TIME OF THE INCIDENT. ALTHOUGH BOTH ANC AND KATANGESE FORCES IN THE AREA COOPERATED WITH THE BOARD IN ITS INVESTIGATION, THE BOARD WAS UNABLE TO REACH A FIRM CONCLUSION AS TO THE ORIGIN OF THE FIRE WHICH BROUGHT THE AIRCRAFT DOWN. THERE WAS EVIDENCE THAT AT THE TIME OF THE CRASH ANC ANTIAIRCRAFT WEAPONS WERE IN POSITIONS WHICH WOULD HAVE MADE IT POSSIBLE FOR THEM TO SHOOT AT THE PLANE, AND THE BOARD HAD THE IMPRESSION THAT THIS MAY HAVE BEEN THE CAUSE OF THE CRASH. 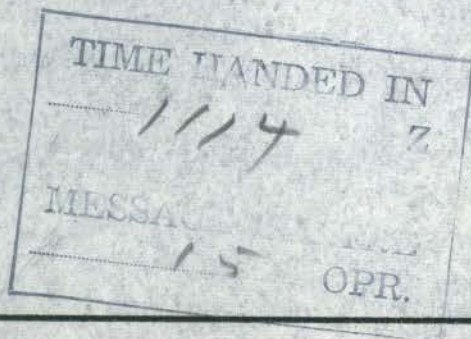
