6 March 1962

Mr. Ritchie, First Secretary of the United Kingdom High Commissioner, Salisbury, told me this afternoon, in the presence of Mr. Dunnett, that he had seen Tshombe this morning and impressed upon him the urgency of his proceeding to Leopoldville, if possible tomorrow. Tshombe raised the questions again of a warrant of arrest and possible parliamentary action against him. Mr. Ritchie expressed full confidence in the United Nations guarantees.

Immediately afterwards, I went to see Tshombe, who said he had fixed 15 March as the date for his departure to Leopoldville, and expected in the meantime to receive further guarantees he had requested. After re-iterating all the previous assurances, I informed him of the contents of your cable EV-340, which I will confirm to him in writing. This seemed to please him and prompted long explanations about the studies and proposals which he was preparing for the meeting, without however giving clues to any specific points. He repeated at length the reasons for requesting all possible guarantees which were, he said, not due to "personal fear" but to the necessity of assuaging the anxiety of the population.

In recalling his imprisonment in Coquilhatville, he enumerated the sufferings of the population which led, inter alia, to continuous prayers and self-imposed penitence, going to the extent of sexual abstinences imposed by the women!

I pressed him to anticipate the date of departure and he finally said that the 15th March would be the latest and he would make efforts to go sooner. As a means of impressing him further on the solemn nature of the United Nations guarantee, I suggested that he invite the British, American and French Consuls to witness a restatement of the assurances which I would make in their presence. I had previously discussed this with the Consuls concerned and all agreed to attend if invited. He found this very useful and suggested that his cabinet ministers be also present. The performance will probably take place today. He mentioned that about ten to fifteen people would go with him to Leopoldville and he hoped to have suitable accommodation for everybody. I have a feeling he wishes to take even his cook along!

The conversation then turned to yesterday's Kamina incidents which I tried to minimize. He calmed down but upon my return to the office, he telephoned and reported he had received a message from Kaminaville according to which the United Nations authorities at the base had called Kasongo Niembo three times at 1800, 1900 and 2105 hours, giving him an ultimatum to surrender, failing which he would be attacked today. The Grand Chef apparently requested the evacuation of women and children from Kaminaville. Tshombe was again given assurances that this incident was not part of an attack against Kaminaville.

During the meeting, the question of the Kilubi hydro-electric plant was also discussed and he agreed to the constitution of a joint party which would survey the installations of the plant and determine what would be required to put the plant back into operation. Further steps to reopen the plant would be discussed later.

Finally he raised the question of Cornaz which has been referred to you in my Elleo-400.
