

1. In the event that the Ref would be executed, I see the press media dividing itself in three groups as follow:

- a. a group going with Phase One;
- b. a group with phase two or three; and
- c. the last group which would more than likely remain here.

- a. the cell is composed of two Capts from Senegal, ID #....Capt S Tall and ID#....Capt H Tall and myself;
- b. at any one time, I have around 10/15 press media pers on the ground;
- c. the essential persons are those described in para 1a above;

UNAMIR HAC CELL

General

1. The UNAMIR HAC presently has a strength of four military personnel, three Canadians and one Nigerian.

2. The cell also has a Rwandese family which sought refuge with the HQ at the commencement of hostilities and the head of this family has been working with the HAC cell without pay since.

- c. The MSF members would have to move out in a bus or truck given that they have but one vehicle.
- d. The Rwandese family should be transported in APC and evacuated by aircraft to Nairobi.
- e. The Rwandese UN workers would have to be evacuated by

SUBJECT: Weekly Situation Report (SITREP)

A. Accommodation, Living

- a. Hotel Chez Lando - Negotiated a UN rate (\$400 per month) and obtained commitment to set aside a block of 31 rooms for UN staff. Rooms to be rented by staff directly. Owner to use initial months proceeds for repair and renovation. Commitment is for 6 months.
- b. Hotel Diplomat - Previous rate/availability commitment has been abandoned. Obtained commitment of management to hold rooms for UN staff as they open up. Due to high demand staff members must check on a daily basis to assure obtaining accommodations. A number of staff members have already checked into this facility. Rates have been going up daily. Check with Terry Massilidis to obtain most recent negotiated rate. A monthly rate may be available. No running water. Electricity limited to several hours daily.
- c. Hotel Mille Collines - The Sabena management company is in the process of restoring the Hotel. American military is negotiating a large block of rooms. If finalized there will only be 27 rooms available. Water and electricity will be fully restored. Room rates will be between \$80-100 per night.
- d. Hotel Meridien - A technical/management team arrived on 8 August 1994. They will perform a detailed survey to determine level of work necessary to restore hotel facility. While, their decision is not yet known discussions have been ongoing through NYHQ and Hotel management to make entire facility available for UN MSA staff members. More information should be available later in week.
- e. Belgian Cooperative Village - Clean-up and restoration of power system has been completed. Residences for SRSG and FC are ready for furnishing and occupancy. Other residences are ready for occupancy by Staff Officers.
- f. 500 Man Transit Camp - Due to delays in release of equipment from Migrants problems in securing adequate transport, only a small portion of the (10 out of 29) containers out of 29) has been delivered to Kigali. A review of the project made by new BMS engineering staff. Due to difficulties in site work and infrastructure (water and sewage) they will propose an alternate location. Advantage of existing facilities and will allow much more rapid progress.
- g. Rubb Hall Warehouses - 4 of these structures (10 x 24 meters) are currently in the operational theater. 4 more are awaiting delivery from UNOSOM (see transport problem above). Arrangements are being made to move these items from the airport back to the LOG BASE. Blouin at LOG BASE has indicated need for two of these structures. We are

awaiting instructions from Plans Group concerning proposed location of 6 additional units. In addition, we require redeployment of site superintendent (Tom Guggenheim) from UNOSOM to UNAMIR for effective installation of these structures (see Personnel).

B. Accommodation, Offices, Warehouses and Workshops

- a. Amahoro HQ - Civilian staff, and MILOBS are being cleared from rooms used as accommodation over last four months of the war, freeing up necessary office space. Staff Officers should also be moving out later this week. A plan for Administration staff office allocation has been completed. Plans for political and military staff office allocation will be requested in order to complete building plans.

- b. Chez Lando - Office space at Chez Lando has been secured on a no cost basis. UN will be responsible for cleaning and repair of facilities used.

- c. Amahoro Basketball Stadium - Potential offices at base of Amahoro basketball stadium were located. B&R were given work order to clean space. If approved, space will be used for service staff of BMS and B&R. B&R will then be given work order to repair glass and locks in facility. It is estimated that these offices could accommodate between 25-30 staff.

- d. Vehicle Maintenance Facilities - B&R has been given work order to clean and repair (door locks and roof) former Transport Workshop that will now be used by British. 10 Airborne Workshops. General Manager of IVECO has arrived and is offering entire facility and equipment for \$6,000 per month. B&R have cleaned facility and are using it for servicing of A-line vehicles. Acting CTO will visit facility to determine space allocation required for his staff to work in this facility as well.

- e. Communications Workshops - Reconnaissance of former Comms workshop was performed. B&R was given work order to install metal shelving and workbenches in this facility. Acting CCO has expressed concern about providing security there.

- f. LOG Base - Clean-up and repair to the LOG Base has essentially been completed. The facility is currently being used. Two diesel fuel tanks with a capacity of approximately 60,000 liters each have been restored, including fuel pump. All warehousing and fuel supply has been moved from the airport to this facility.

- g. Miscellaneous - Various contingents, military companies and MILOBS have begun to redeploy. Requests have begun to arrive for repair and renovation of facilities. BMS currently has no material stores and staff is extremely limited, resulting in delays for addressing any but the most urgent needs.

C. Catering Facilities

- a. ATCO Kitchen - no components of the ATCO Kitchen have been shipped from UNOSOM. In addition, we are not sure of the condition of the unit as it has been sitting in Somalia for many months. We do not anticipate that the facility can be installed and rendered operational for at least 8 weeks.

- b. Chez Lando Catering Facilities - We have received a letter of intent from the owner of Chez Lando offering UNAMIR the use of its commercial kitchen facilities and banquet halls. This offer is at no rental cost to UNAMIR for 6 months. Charge will be those costs necessary to clean and repair the structure (roof and glass damage). We anticipate that the catering contractor will bring in its own equipment to replace that damaged or stolen during the war.

- Can we continue doing this in 2 or 3 months?*
- a. Current Stores Level - Currently there are no stores of construction materials throughout the mission area. Master requisitions have been prepared for civil, electrical, plumbing and military defence stores. However, since amounts will probably require approval of HQ Committee on Contracts it is not anticipated that these materials will be available in the mission area for 2-3 months. In the interim, materials are being purchased directly by contingents, as an IOR, or through B&R contract.
- b. Imprest Account - The BMS has not received approval for an Imprest Account. Under the present circumstances such an account would facilitate rapid purchase of small quantities of construction materials. It is recommended that an IA of \$10,000 be established with single item purchase limit of \$999. *Essential*

E. Personnel

- a. Current Personnel Level - The current level of personnel stands at three, including CBMSO and two temporary staff members (Steve Etsell and Eddie Oler) who have arrived on 8 week loan from UNPROFOR. Mihail Sobec, originally assigned to BMS, is being used in logistics and R&I due to lack of staff in these areas. Two additional staff members requested, Declin Corrigan of UNOMUR and Tom Guggenheim of UNOSOM have not been reassigned. As we are entering a rapid build-up period the demands on BMS are great. It is imperative that these staff members arrive in mission area ASAP.
- b. Casual Labor - No method for hiring local labor has been established. As a result all casual labor (cleaners and unskilled construction) are being hired and managed through Work Order Requests to B&R (see below).

E. Brown & Root

A B&R management team arrived in the mission area approximately 2 weeks ago. They spent the initial week setting up office space and workshop facilities (IVECO). Since then A work order system was instituted immediately in order to control work requests and to institute cost control systems. Each Chief of Section using B&R services is required to complete a Work Order Request prior to B&R initiating work on a project. B&R will begin a system for providing regular project accounting information in order for Chiefs of Section to manage their budget allocations.
