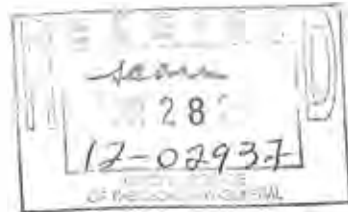

I have the honour to write in Nauru's capacity as Chair of the Alliance of Small Islands States (AOSIS). AOSIS has 43 Members and Observers who span the oceans of the world.

Allow me to invite you, in this capacity, to be the guest of honor at a luncheon with the Members of AOSIS. There are a number of issues of mutual concern which would be beneficial for us to discuss. They include the United Nations Conference on Sustainable Development (UNCSD or Rio+20), oceans, climate change, and the way forward for Small Island Developing States (SIDS).

If you are amenable to the possibility, may I suggest a luncheon sometime in April/May? I will be guided by your preference of date, though I would note for your consideration that from 7 - 25 of May, there will be meetings of the UNFCCC subsidiary bodies in Bonn, Germany, which may affect attendance. Should this luncheon be possible, I would be pleased to work with your Office in preparation for the requested meeting.
