Subject: CIVPOL Sitrep from 06:00 - 29/6 to 06:00 - 30/6/95

Object:

I. GENERAL SITUATION:

The security situation in the country continues to be generally calm.

II. FACTIONAL ACTIVITIES:

1. GNU, OTHER LOCAL AUTHORITIES:

PMT - KIGALI Prefecture:

A. Visited IOM office on 28/6/95 and met the Chief of Mission in Rwanda who disclosed that there have been Military training in Zairian refugee camp but were conducted without Military hardware and incendiary. The chief also confirmed that flights were often seen in eastern Zaire with consignment but the nature and contents unknown.

B. The team also visited the Ministry of Rehabilitation on 29/6/95 and met the Director who expressed high appreciation to UNAMIR for its co-operation and assistance during the incident at the closed Kibeho Camp despite the differences that were encountered. The Director further disclosed that the Ministry has got all the Govt. needed to facilitate the resettlement of IDPs in their respective home communes. He also appealed to UNAMIR for assistance to repair access roads leading to resettlement areas.

2. RPA:

PMT - GIKONGORO Prefecture:

The team was informed that 1 refugee was arrested by RPA soldiers in March 1995 whilst he was attending church service and detained in Gikongoro prison. Reason for the arrest unknown. Human Rights informed.

PMT - GITARAMA Prefecture:

Visited Gitarama prison on 29/6/95 and reported that there was a shooting incident by RPA soldiers during the night at about 01.00 hrs which left 4 prisoners dead and 3 others seriously injured. The injured have been evacuated to Kabgayi Hospital. The RPA guards at the prison claimed that the prisoners attempted to escape when they were shot. Human Rights informed. Investigation in progress.

2. SOCIAL:

Social advancement centers are on the increase in the country and has facilitated social gatherings amongst the local population in all spectrum of life, even though there are fears of moving in the night.

3. COMMERCIAL:

There are visible growth in retail businesses of consumer's goods in the prefectures.

4. ECONOMIC:

The domestic economic situation is making subsistence living very hard and out of reach of many in the prefectures.

5. HUMANITARIAN:

PMT - GIKONGORO Prefecture:

Visited Burundi refugee camp at Kigeme Commune on 28/6/95 and met the Deputy President of the camp who disclosed that the number of refugees has now reduced to 2,147. The Deputy President also complained of inadequate supply of food to the refugees in the camp. He appealed to UNAMIR for assistance.

PMT - BUTARE Prefecture:

Visited Way station on 28/6/95 and reported that there were 204 IDPs from neighbouring countries awaiting evacuation to their respective home communes. 113 out of this number were evacuated to their various home communes. The team also reported that 83 IDPs from Burundi were evacuated to Kigombe Commune on 27/6/95.

PMT - CYANGUGU Prefecture:

Reported that there were 64 refugees from neighbouring countries in Bugarama Commune awaiting evacuation to Nyamgatare Camp.

III. OWN ACTIVITIES:

1. CIVPOL HEADQUARTERS:

UNAMIR CIVPOL HQ continued coordination and monitoring of activities of CIVPOL Observers in the Prefectures.

2. CIVPOL MONITORING TEAMS:

PMT - KIGALI Prefecture:

Reported that it is assisting the local Gendarmerie in the investigation of a case of theft of a Multi-purpose Cutting machine the property of SAMARITA Personnel. The incident occurred on 29/6/95 at about 07.15 hrs in Remera area.

PMT - KIBUYE Prefecture:

The team visited Mugunda Sector in Bwakira Commune on 28/6/95 and met the counsellor who disclosed that the security situation in the area has been calm. The counsellor also informed the team that 2 1959/60 refugees have since returned to the sector from Zaire.

3. TRAINING:

The graduated UNAMIR trained gendarmes at Ruhengeri National Training School are now awaiting deployment. Also preparation of handout in English lessons is in progress. In the same vein the teaching documents for the take off of the Communal Police is in the pipeline.

IV. CRIME WAVE

UNAMIR CIVPOL Monitoring Teams in the prefectures have reported that criminal activities have reduced to some extent.

V. Investigation:

CIVPOL Monitoring Teams in the prefectures are assisting Human Rights Monitors in the investigation of Human Rights violation cases. The teams are also assisting UNAMIR Military Police in motor accident cases throughout the prefectures.

I. GENERAL SITUATION:

The security situation in the country continues to be generally calm.

II. FACTIONAL ACTIVITIES:

1. GNU, OTHER LOCAL AUTHORITIES:

PMT - BUTARE Prefecture:

Observed a masse grave in front of the commune building prepared for the re-burial of the remains of Kibeho victims.

2. SOCIAL:

Social advancement centers are on the increase in the country and has facilitated social gatherings amongst the local population in all spectrum of life, even though there are fears of moving in the night.

3. COMMERCIAL:

There are visible growth in retail businesses of consumer's goods in the prefectures.

4. ECONOMIC:

The domestic economic situation is making subsistence living very hard and out of reach of many in the prefectures.

5. HUMANITARIAN:

PMT - BUTARE Prefecture:

Patrolled Runganza Commune on 27/6/95 and was informed that the commune has a population of 28,350 and 457 orphans who are living with other families. It was further revealed that the commune has no orphanage centre to keep the orphans.

III. OWN ACTIVITIES:

1. CIVPOL HEADQUARTERS:

UNAMIR CIVPOL HQ continued coordination and monitoring of activities of CIVPOL Observers in the Prefectures.

2. CIVPOL MONITORING TEAMS:

PMT - GIKONGORO Prefecture:

A. The team patrolled Rwaniko Commune on 27/6/95 and was informed that the crime wave in the commune is on the increase.

B. The team also reported that bandits suspected to be RPA soldiers 2 weeks ago at Mata Sector in Rwamiko Commune robbed families of undisclosed amounts of money, cows and bicycles. In the process of the robberies, one local was killed. Investigation in progress.

C. In another development the team reported that most of the IDPs who returned from Kibeho Camp to the commune are reported to have fled to Burundi because of the security situation in the area.

PMT - RUHENGARI Prefecture:

Visited Butare Commune MSF Medical Centre on 27/6/95 and was informed that for the past 3 weeks locals have stopped reporting to the centre for treatment because of rumours circulating among locals that the Govt. of Rwanda has distributed poisonous drugs to the health centres. Investigation in progress.

PMT - GITARAMA Prefecture:

A. A joint CIVPOL/Human Rights team visited Rutobwe Commune on 27/6/95 and met the Bourgmestre who disclosed that the security situation in the area has been calm.

B. The team also reported that the FC visited the Sector and was briefed on the general situation in the Prefecture.

PMT - KIGALI Prefecture:

Reported that there was an armed robbery incident on 27/6/95 at Kimihurura area involving UNAMIR personnel. A lot of valuables were stolen during the robbery. Military Police are already investigating the case.

PMT - GISENYI Prefecture:

Reported that the MSF (Medecins Sans Frontieres) in Gisenyi Prefecture had on 27/6/95 written a letter to Gendarmerie brigade of Gisenyi threatening to stop their activities over the impounding of their vehicle since 15/6/95. The team on 28/6/95 through its efforts has collected the said vehicle and handed it over to MSF.

3. TRAINING:

The graduated UNAMIR trained gendarmes at Ruhengeri National Training School are now awaiting deployment. Also preparation of handout in English lessons is in progress. In the same vein the teaching documents for the take off of the Communal Police is in the pipeline.

Object:

I. GENERAL SITUATION:

The security situation in the country continues to be generally calm.

II. FACTIONAL ACTIVITIES:

1. GNU, OTHER LOCAL AUTHORITIES: NTR.

2. SOCIAL:

Social advancement centers are on the increase in the country and has facilitated social gatherings amongst the local population in all spectrum of life, even though there are fears of moving in the night.

3. COMMERCIAL:

There are visible growth in retail businesses of consumer's goods in the prefectures.

4. ECONOMIC:

The domestic economic situation is making subsistence living very hard and out of reach of many in the prefectures.

5. HUMANITARIAN:

PMT - GISENYI Prefecture:

Conducted joint patrol with Human Rights team to Kabaya Commune on 25 June 95. At Rwili Sector, the team found 285 refugees comprising of 50 men, 50 women, 110 children and 75 herdsmen. The refugees were said to have crossed into Rwanda from Zaire since May 95. The refugees complained of lack of food and farm implements. The security situation was reported calm.

PMT - BUTARE Prefecture:

Visited Rusatera Commune prison on 26/6/95 and reported that the prison is overcrowded with 165 inmates and with poor sanitary conditions. Human Rights informed.

III. OWN ACTIVITIES:

1. CIVPOL HEADQUARTERS:

UNAMIR CIVPOL HQ continued coordination and monitoring of activities of CIVPOL Observers in the Prefectures.

2. CIVPOL MONITORING TEAMS:

PMT - GIKONGORO Prefecture:

A. Patrolled Kinyamakara Commune on 25/6/95 and met the Bourgmestre who disclosed that out of 649 locals from the commune who took refuge at Kibeho Camp after the war, only 448 have so returned. The whereabouts of 201 is unknown. The Bourgmestre further revealed that 24 of the returnees were found to have taken part in last year's genocide and were arrested and detained in the commune cell by RPA. The team visited the detention centre and discovered that the suspects are detained in a small room with poor sanitary conditions. The Bourgmestre however attributes their continued detention in the cachot to lack of transport to transfer them to Gikongoro main prison. Human Rights informed.

B. The same team was informed that a grenade was found few meters away from the main gate of the Human Rights office and later picked by RPA soldiers. Investigation conducted revealed that an unidentified RPA soldier during a drinking spree got himself drunk and started indiscriminate firing. He was being pursued by fellow RPA soldiers when the hand grenade fell from his pocket. The BN. Commander has been contacted on the conduct of his soldier.

PMT - GITARAMA Prefecture:

Patrolled Nyabinkenke Commune on 21 June 95 and visited the commune cell. During their interview with the inmates, the RPA in charge of the cachot arrived and ordered the team to stop further discussions and hand over their notes to him. The team did not oblige but after an hour and half deliberations, the team was allowed to leave the area. The RPA officer accused UNAMIR of spreading falsehood about the commune to his superiors. The attitude of the RPA soldiers is uncalled for as the team went to the cachot with a written permission from the Prefect of Kiyumbe. The matter has since been reported to BN. Commander.

PMT - CYANGUGU Prefecture:

Reported that on 24 June 95, between 20.30 hrs and 22.00 hrs, a group of bandits armed with automatic weapons robbed 2 locals of Mubumbano Sector of Kagano Commune of some unspecified amount of money and personal effects. In both incidents, the daughters of the victims who were present were forced by the bandits to carry the items robbed to their waiting boat on the shore of the lake. The bandits are suspected to have come from Zaire. Investigation in progress.

3. TRAINING:

The graduated UNAMIR trained gendarmes at Ruhengeri National Training School are now awaiting deployment. Also preparation of handout in English lessons is in progress. In the same vein the teaching documents for the take off of the Communal Police is in the pipeline.

I. GENERAL SITUATION:

The security situation in the country continues to be generally calm.

II. FACTIONAL ACTIVITIES:

1. GNU, OTHER LOCAL AUTHORITIES:

PMT - KIGALI Prefecture:

Visited the office of the Public Prosecutor and was informed that no date has yet been fixed for the trial of genocide suspects. Human Rights informed.

2. SOCIAL:

Social advancement centers are on the increase in the country and has facilitated social gatherings amongst the local population in all spectrum of life, even though there are fears of moving in the night.

3. COMMERCIAL:

There are visible growth in retail businesses of consumer's goods in the prefectures.

4. ECONOMIC:

The domestic economic situation is making subsistence living very hard and out of reach of many in the prefectures.

5. HUMANITARIAN:

PMT - KIGALI Prefecture:

A. Visited Kigali Central Prison on 26/6/95 and reported that the number of inmates has increased to 9732 with poor sanitary conditions. No deaths have been reported. Human Rights informed.

B. The team also visited Ndera IDPs camp and was informed that there are 152 IDPs without homes awaiting re-settlement. The team further reported that some IDPs have been in the camp for months hoping that their relatives would come to collect them.

III. OWN ACTIVITIES:

1. CIVPOL HEADQUARTERS:

UNAMIR CIVPOL HQ continued coordination and monitoring of activities of CIVPOL Observers in the Prefectures.

2. CIVPOL MONITORING TEAMS:

PMT - KIBUYE Prefecture:

Patrolled Rwamatamu Commune where it delivered drugs donated by UNICEF Pharmacy to Karengera Hospital on 25/6/95. The team also visited Ngoma Hospital in Gishyita Commune and met the Director renovating the hospital. The Director informed the team of the presence of undesirable elements in the area who have broken their water pipe twice in a month. Investigation in progress.

PMT - GITARAMA Prefecture:

Patrolled Rugalika Sector of Runda Commune on 24 June 95 and monitored the distribution of relief materials to the orphans concentrated in the area. the spokesman of the locals on behalf of the community is appealing to UNAMIR for assistance as orphans are every where in the commune.

3. TRAINING:

The graduated UNAMIR trained gendarmes at Ruhengeri Nat

Training School are now awaiting deployment. Also preparation of handout in English lessons is in progress. In the same vein the teaching documents for the take off of the Communal Police is in the pipeline.

Subject: CIVPOL Sitrep from 06:00 - 24/6 to 06:00 - 26/6/95

Object:

I. GENERAL SITUATION:

The security situation in the country continues to be generally calm.

II. FACTIONAL ACTIVITIES:

1. GNU, OTHER LOCAL AUTHORITIES:

PMT - GIKONGORO Prefecture:

Reported that on 24/6/95 the Prefect of Gikongoro addressed a group of IDPs at Murabi IDPs camp where he assured them of their security in the camp. Human Rights informed.

2. RPA:

PMT - KIBUYE Prefecture:

A. Reported that RPA have intensified both day and night patrols in the prefecture. The team also reported that arbitrary arrests of locals by RPA on the ground of having participated in the genocide is on the increase in the prefecture.

B. The team was informed on 23 June 95 while on patrol that a local teacher was arrested by RPA in March 95 and detained in Kibuye prison. No reason was given for the arrest. Human Rights informed. Investigation in progress.

2. SOCIAL:

Social advancement centers are on the increase in the country and has facilitated social gatherings amongst the local population in all spectrum of life, even though there are fears of moving in the night.

3. COMMERCIAL:

There are visible growth in retail businesses of consumer's goods in the prefectures.

4. ECONOMIC:

The domestic economic situation is making subsistence living very hard and out of reach of many in the prefectures.

5. HUMANITARIAN:

PMT - BUTARE Prefecture:

A. Reported that 40 former refugees who have already settled in their respective home communes crossed into Burundi on 24/6/95. According to their spokesman, their mission was to inform their relations in refugee camp in Burundi to return to Rwanda after monitoring the security situation.

B. The team further reported that it monitored the distribution of food items to locals in Gikongoro town on 23 June 95.

C. In another development, locals in Njabisina Commune had complained of lack of farm implements and are appealing to UNAMIR for assistance.

PMT - KIGALI Prefecture:

Visited Ndera Camp on 24/6/95 and reported that 130 refugees were dispatched to their home communes with 145 awaiting evacuation.

III. OWN ACTIVITIES:

1. CIVPOL HEADQUARTERS:

UNAMIR CIVPOL HQ continued coordination and monitoring activities of CIVPOL Observers in the Prefectures

2. CIVPOL MONITORING TEAMS:

PMT - GIKONGORO Prefecture:

Patrolled AOR and reported that the security situation is calm. The team disclosed that investigation into the theft of a vehicle belonging to Goal Ireland personnel is in progress.

PMT - RUHENGARI Prefecture:

Patrolled Kinigi Commune on 23 June 95 and met the bourgmestre who disclosed that the security situation in the area has been calm. The bourgmestre is however appealing to UNAMIR in areas of health care as inhabitants of the commune travel up to 25 km in search of medical centre.

PMT - BUTARE Prefecture:

A. Disclosed that Burundi soldiers have been deployed to Kanyaro-BAS border post. The security situation in the area is however calm.

B. The same team patrolled Miyaro Commune on 24/6/95 and was informed that during the night of the previous week gun shots suspected to have been fired by RPA soldiers were heard in the area. Reasons for the firing unknown. Investigation in progress.

PMT - GITARAMA Prefecture:

Patrolled Bukinga, Nyakabanda, Nyabikenge and Kayenzi communes within Gitarama Prefecture on 24/6/95 and was informed that the security situation in the communes is calm. Locals were seen carrying out their businesses unimpeded.

PMT - GISENYI Prefecture:

Reported that the team is assisting RPA in the investigation of a murder case which took place in Rwerere Commune on 24/6/95. Investigation in progress.

3. TRAINING:

The graduated UNAMIR trained gendarmes at Ruhengeri National Training School are now awaiting deployment. Also preparation of handout in English lessons is in progress. In the same vein the teaching documents for the take off of the Communal Police is in the pipeline.

Visited the chairman of the taskforce on abandoned properties on 14 June 95 who disclosed to team that UNAMIR personnel occupying abandoned houses and had hitherto entered into tenancy agreement with emergency landlords should regard such agreement as null and void. He further advised those affected to sign new contracts with the taskforce or vacate without delay. The chairman appealed to UNAMIR to have legal backing on houses being occupied to avoid any friction with the govt. of RWANDA.

PMT - GIKONGORO Prefecture:

Reported that a plan has been put in place by the Rwandan Govt. to close down Murambi IDPs Camp which has about 1,500 returnees. The IDPs were alleged to have been involved in series of banditry activities within Gikongoro Prefecture.

Reported that on 14 June 95 a Human Rights personnel was on her way from TARE to KIGALI robbed of her valuable documents and 100 USD by locals dressed in RPA uniform. Investigation in progress.





B. The team was further informed that Tutsi extremists in Runda Commune of Gitarama Prefecture have reported of killing the IDPs who have returned to the commune during the night. Human Rights informed. Investigation in progress.

PMT-GITARAMA Prefecture:

Reported that veh. No. UNAMIR 1069 (4 Runner) which was stolen at gun point on 15 May 95 at about 14.30 hrs by 3 armed RPA soldiers on the Gitarama-Kibuye road had been recovered by a joint team of MILOBS, Mali Coy and RPA during a heli search mounted in the area on 16 May 95. Information had it that the veh. was abandoned by the soldiers after they had removed the ignition key and re-painted it with mud.

1.2 PMT -KIBUYE Prefecture:

Reported that a local staff of the Ministry of National Rehabilitation at MABANZA commune office had been arrested and detained at Kibuye prison on 9/5/95 for allegedly selling relief items and misappropriation of Funds. Investigation in progress.

RPA1.3 PMT - GITARAMA Prefecture:

Reported that a 14 year old local pupil had been shot by an RPA soldier based at Gitarama Brigade for no apparent reason. The incident occurred at Nyabisindu sector of Nyamabuye

commune. The victim is reported to have been seriously injured and had been transferred from the Kabgayi hospital in Gitarama to Kigali for further treatment. Human Rights informed. Investigation in progress.

1.1 PMT - RUHENGARI PREFECTURE

Patrolled NDUSU and GATONDE Communes and met the representative of the Ministry of Rehabilitation at NDUSU who disclosed to the Team that some IDPS have left the Communes following the eviction order by the prefect of RUHENGARI while others turned down the order giving reasons of insecurity in their communes.

1.2. RPA :

The Team also reported that RPA continued mounting of checkpoints at several points in and outside Ruhengeri where UN vehicles are subjected to thorough search.

The Team revealed further that a total of 19 locals have been detained by RPA at NDUSU and GATONDE Gendarmerie Brigade cells for participating in last year's genocide. Human Rights informed. Investigation in progress.

PMT-Butare Prefecture;

Reported that on 10/5/95, at about 2045 hrs, two armed men dressed in RPA uniform robbed some IMC personnel at BUTARE of 1,160,000 Francs, 1300 Dollars and a Motorola. Case referred to Gendarmerie Brigade for investigation while PMT is monitoring the process.

PMT GIKONGORO PREFECTURE.

Reported that RPA soldiers on 11/5/95 handed over a local to ZAMBATT who was said to have taken refuge in a nearby bush for over two weeks following the massacre at KIBEHO camp on 22/5/95. He is receiving medical treatment at KAGARE hospital.
