

The United Nations Observer Mission Uganda/Rwanda presents its compliments to the Secretary of Defence, requests his assistance in the following matters and has the honour to state that, in view of the prevailing difficulties of routing UN cargo aircrafts from Nairobi to Kigali, it has become necessary to route the aircrafts with stores and personnel through Entebbe International Airport through the kind courtesy of the Ugandan Government. Besides, due to the same reason, some of the essential supplies require to be met from Kampala/Kabale.

2. In view of the foregoing, may I kindly request you to facilitate the following:

**- UN RESTRICTED -**

- a. Landing of UN aircrafts carrying stores and personnel at Entebbe International Airport.
  - b. Clearance of the stores at the Entebbe Airport.
  - c. Entry of UNAMIR vehicles with essential personnel to Uganda at Kagitumba or Katuna border crossing point for collection of stores and essential items from Kampala/Mbarara/Kabale etc.
  - d. Passage of UNAMIR personnel to Rwanda through Kagitumba or Katuna border.
3. The United Nations Observer Mission Uganda/Rwanda avails itself of this opportunity to renew its highest esteems and considerations at all times.

SUBJECT: Rerouting of supplies for UNAMIR via Uganda

Dear Mr. Ambassador,

As I informed you on the telephone this afternoon, the continuing combat around Kigali airport necessitates that supplies for UNAMIR be rerouted. We would plan to reroute such supplies via Entebbe airport, which already is receiving supplies for UNOMUR. From Entebbe, the supplies would be taken into Rwanda and to Kigali by land.

We would be grateful if you could urgently confirm that this proposal for rerouting via Entebbe is acceptable to the Government of Uganda. Upon receiving this confirmation, the required arrangements would be initiated in coordination with the Ugandan authorities.

Please accept, Mr. Ambassador, the assurances of my highest consideration.
