S E C R E T CIV 17. LINNER MACEOIN FROM ENGLUND TESHOME REUR SV 35

1. PAKASSA IS KEPT IN THE APARTMENT ON SECOND FLOOR OF THE TRANSPORT OFFICE AT THE ONUC GARAGE. WHEN HE IS ALONE THE DOOR IS LOCKED. THE ORDINARY GUARDS ARE OUTSIDE. THE WINDOW OF HIS ROOM FACES THE GARAGE COMPOUND. VERY FEW PEOPLE, TESHOME, MYSELF AND SOME OFFICERS ONLY, KNOW WHERE HE IS AND WE ARE TRYING TO KEEP HIM WITH US AS DISECREETLY AS POSSIBLE

2. THE BEST GUARANTEE IS HOWEVER THAT HE IS VERY AFRAID AND THAT HE DOES NOT WANT TO LEAVE OUR PROTECTION

3. HIS FAMILY IS SAFE BUT THERE ARE 3 PREVOTE GUARDS IN THE HOUSE

4. PAKASSA TOLD THE FOLLOWING ABOUT HIS ESCAPE, HIS CELL WAS ORDINARLY GUARDED BY 2 SOLDIERS. ON THE EVENING WHEN HE ESCAPED THERE WAS ONLY 1 GUARD. PAKASSA SUCCEEDED TO SNEAK OUT WHEN THE GUARD WAS DISTRACTED BY SOMETHING ELSE. KNOWING WELL THE CAMP KETELE COMPOUND HE FOUND HIS WAY THROUGH A PASSAGE THAT HE KNEW WAS NOT GUARDED. HE TRIED TO REACH OUR HQ BUT LOST HIS WAY AND CAME TO THE ONUC GARAGE WHERE AN ETHIOPIAN OFFICER TOOK CARE OF HIM AND CONTACTED TESHOME. THE ESCAPE TOOK PLACE AROUND 8 OCLOCK IN THE EVENING

5. WE HAVE INTERROGATED PAKASSA AND 1 FATHER ABOUT KONGOLO.

THE FATHER HAS CONFIRMED THAT PAKASSA BY PERSONAL INTERVENTION SAVED THE LIVES OF 4 MISSIONARIES AND THAT HE PERSONALLY MADE SURE THAT THE MISSIONARIES WERE WELL TREATED. THE REPORT OF THE INTERROGATION WILL BE SENT BY NEXT POUCH. PLEASE ADVISE IF YOU WANT MORE DETAILS IMMEDIATELY. PAKASSA TOLD TESHOME AND MYSELF THAT HE IS PREPARED TO PROVE HIS INNOCENCE BEFORE ANY COURT AND THAT HE WANTS TO HAVE A LAWYER TO DEFEND HIM. HE FURTHER WANTS UN PROTECTION UNTIL THE COURT HAS GIVEN ITS VERDICT

6. PAKASSA HAS NOT BEEN MALTREATED DURING HIS DETENTION AT KETELE. HE WAS CONSEQUENTLY THREATENED BY THE SOLDIERS WHO SUCCESSFULLY DECREASED HIS MEALS. ON THE LAST DAY HE SAID HE GOT NOTHING TO EAT. LUNDULA HAD GIVEN ORDERS TO TREAT HIM CORRECTLY

7. WE HAVE ALSO A REPORT FROM HIM REGARDING HIS ACTIONS IN CONNECTION WITH GIZENGA. HE STATES THAT HE WANTED TO SEND A DELEGATION TO STAN TO NEGOTIATE WITH LUNDULA AND THAT HE ISSUED ORDERS THAT THE ARMY SHOULD NOT INTERFERE IN THE GIZENGA MATTER BEING A PROBLEM OF POLITICIANS AND NOT FOR THE ARMY. PAKASSA DENIES HE INTENDED TO MARCH TO STAN TO SAVE GIZENGA. PAKASSA SAYS THAT HE WENT TO STAN BY HIS OWN FREE WILL AND THAT HE HAD TO ESCAPE IN A TRUCK TO KONGOLO WITH HIS ESCORT AS HIS SOLDIERS DID NOT WANT HIM TO GO


