1. Further to my memorandum dated 23 February 1978, I am now informed that the activities of Mr. Fathih Khaouane Bouayad-Agha will be limited to participation in the work of the Mission in Algiers, and that his travel to and from Algiers will be paid for by the Algerian Government.
