SUBJECT: PROGRAMME OF ACTIVITIES	

1. On my arrival in Kinshasa, I was greeted by a UNDP Agent who provided transportation and had booked hotel room for me.
2. Early the following day, I met UNDP Deputy Resident Representative / Operations, Mr. Adama Zampalegre who gave me an office, a car and appointed a temporary secretary to my office.
3. Later the same day we had discussion on the administrative matters of the Liaison Office.
4. Furthermore, together we worked on the first draft budget of the office. The final version agreed upon, will be sent to UNAMIR-HQ
5. On the 24 and 25 July 1995, the UNDP Resident Representative Mr. Aliou M. DIALLO received me and briefed me on the over all situation in Zaïre and the refugees camps. We discussed at length the political, military and humanitarian issues involved.
6. There has been no substantial change in the Zaïrean position since Mr. AYELLO's Mission and the Secretary-General's visit.

7. The Zaïrean government is still asking for the setting up of an Inquiry Committee under the UN auspices to clarify the controversial issue of arming and training Rwandese in the refugee camps located in Zaïre.
8. Meanwhile the Prime Ministre announced the restructuration of his Government. No meaningful change was recorded. 4 ministers left and three new ministers entered; the whole operation consisted of reshuffling minister from one department to another.
9. During the same period, the Zaïrean Government has also announced its decision to relocate the refugee camps far from the borders with RWANDA.
10. I also discussed with the Resident Representative Mr. Aliou M. Diallo my programme of activities.
11. The first step will be to pay a courtesy visit to the Zaïrean Authorities mainly the Prime Minister, the Ministers of Foreign Affairs, Defense, Interior and Justice. We will start, hopefully next week, the visits because this week the Prime Minister lost his mother we let the mourning period to be over.
12. We will follow up by the visits of all UN Agencies operating in Zaïre and the main Embassies accredited in Zaïre.
13. Finally, we will travel to the border to visit all the refugees camps.
14. The UNDP Resident Representative Mr Aliou M. DIALLO has kindly promised to accompany me and introduced me to the Zaïrean authorities and the other personalities.
15. On the 24 July I received the CRYPTOFAH-HC-4400 sent from New York since May 2, 1995 by Mr Frank RUSSO (Telecommunications service). The machine is not yet operational. 
