RETURN TO THEIR BATTALION. THE LETTER SHOULD TELL TSHOMBE TO ARREST THESE MEN

AND HAND THEM OVER TO ME. IT SHOULD ALSO STATE THAT WHILE THE SOLDIERS ARE IN THE CONGO NO PUNISHMENT WILL BE ACCORDED THEM. IT SHOULD FINALLY STATE THAT THE UN WILL DO WHAT IS POSSIBLE TO OBTAIN GUARANTEE FOR SAFETY OF LIFE OF THE SOLDIERS WHEN THEY RETURN TO TUNISIA. AS MY LETTER REFERRED TO ABOVE DEMANDED UNCONDITIONAL HAND OVER OF THE SOLDIERS, I AM ASKING YOUR INSTRUCTIONS AS TO WHETHER THE LETTER NOW TSHOMBE REQUIRES SHOULD BE WRITTEN AT ALL. FOLLOWING RECEIVED FROM HIG BDE LULU (OPS 736) QUOTE SITREP NO 456. PERIOD COVERED 211600 B TO 221600 B. TSHIKAPA. PATROL CONFIRMED THAT VILLAGE OF POLOTO 4 MILES SOUTH EAST OF TSHIKAPA, WAS BURNT DOWN AND CROPS DAMAGED ON 17 NOV. NEW VILLAGE OF SAME NAME NOW BEING BUILT ON LULUA SIDE OF KASAI RIVER. ADMINISTRATOR WOULD NOT GIVE PROPER EXPLANATION WHY BURNING NOT IMMEDIATELY REPORTED BUT STATED WOUNDED WERE EVACUATED TO LULU. DIMBELANGE. APPROX 210 ANC FROM BAKWANGA IN AREA FOR INDEFINITE PERIOD. THEY ARE LOCATED AT DIMBELANGE, LAC NUKAMBA, KAFAMBWE AND MUTOMBODIBWE. YESTERDAY THEY FOUND A HOSTILE CROWD ARMED WITH SPEARS, BOWS AND DANE GUNS AT KUNYUNGA 10 KMS SOUTH EAST OF DIMBELANGE.
