COL MUKE VISITED UN HQ THIS AFTERNOON AND DISCUSSED QUESTION OF CONTROL OF EVILLE AIRPORT. HE DEMANDED THAT HE SHOULD HAVE CONTROL OF THE AIRPORT AND INSISTED THAT HE BE ALLOWED TO MAINTAIN SAME STRENGTH AS UN FORCES THIS DEMAND WAS REJECTED BY RAJA WHICH DID NOT PLEASE HIM MUCH AND STARTED QUESTION OF SOV RIGHTY AND SAID UN COULD NOT IMPOSE RESTRICTIONS ON THE FORCES OF KATANGA. HE THEN DEMANDED THAT HIS PLATOON NOW AT THE AIRPORT BE ALLOWED TO PATROL DAY AND NIGHT. RAJA REJECTED THIS DEMAND ALSO AND INFORMED HIM THAT IF HIS PATROL START MOVING AT NIGHT THERE WOULD BE INCIDENTS WHICH WOULD NOT BE IN THE BEST INTERESTS OF GENDARMERIE. HE WAS VERY DISAPPOINTED AND FINALLY DEMANDED THAT HE BE ALLOWED TO MAINTAIN A SMALL GUARD OF 1 NCO AND 3 MEN AT THE CONTROL TOWER ALONG WITH OUR GUARD. RAJA TOLD HIM THAT HE WILL CONSIDER THIS AND LET HIM HAVE AN ANSWER ON 13 SEP. RAJA FEEL TO ENCOURAGES HIM WE MAY ALLOW A GUARD OF 1 AND 3 AT THE CONTROL TOWER AS THIS DOES NOT IMPOSE ANY THREAT. WE HAVE SUFFICIENT STRENGTH AT THE AIRPORT TO MEET ANY THREAT. HOPE YOU WILL AGREE TO RAJAS SUGGESTION TO ALLOW A GUARD OF 1 AND 3 AT THE CONTROL TOWER. COL MUKE HAS BEEN TOLD IN NO UNCERTAIN TERMS THAT ANY MOVE ON HIS PART TO ENTER AIRPORT AREA WILL RESULT INCIDENT WHICH UN WISH TO AVOID AT ALL COSTS



An alternative explanation about the refugees is that we incite them to act violently in the city. Further demonstrations are to be expected. The whole attitude as far as the regime and spokesmen are concerned is one of defiance and provocation. I am protesting to Tshombe about his broken promise but that at present little can be expected from Tshombe until we can assure him that we are prepared to act with determination along the lines suggested in your A-2082.
